**THE ASSAM FIXATION OF CEILING ON
LAND HOLDINGS (AMENDMENT)
ACT, 1959**

further to amend the Assam Fixation of Ceiling on Assam Act
Land Holdings Act, 1956. I of 1957.

Preamble.

WHEREAS it is expedient further to amend the Assam Act
Assam Fixation of Ceiling on Land Holdings Act, I of 1957,
1956, hereinafter called the Principal Act, in the man-
ner hereinafter appearing ;

It is hereby enacted in the Eleventh Year of the Republic of India as follows:—

Short title, extent and commencement. 1. (1) This Act may be called the Assam Fixation of Ceiling on Land Holdings (Amendment) Act, 1960.

(2) It shall have the like extent as the Principal Act.

(3) It shall come into force at once.

Amendment of section 3 of Assam Act I of 1957. 2. In section 3 of the Principal Act, the following shall be substituted for clause (j), namely:—

“(j) ‘person’ includes a family, a company and a body corporate;”

Amendment of section 4 of Assam Act I of 1957. 3. In sub-section (1) of section 4 of the Principal Act, the following commas and the words shall be omitted, namely:—

“, either by himself or through any member of his family,”.

Amendment of section 5 of Assam Act I of 1957. 4. In section 5 of the Principal Act, the following words and the comma shall be omitted, namely:—

“, either by himself or through any member of his family,”.

Amendment of section 7 of Assam Act I of 1957. 5. In sub-section (1) of section 7 of the Principal Act, the following words shall be omitted, namely:—

“, on their own behalf and on behalf of their family”.

Amendment of section 16 of Assam Act I of 1957. 6. In section 16 of the Principal Act, in sub-section (2) the “full stop” at the end shall be deleted and the following shall be added, namely:—

“, on the same rate of revenue or rent for such class of land in the neighbourhood.”

Amendment of section 19 of Assam Act I of 1957. 7. In sub-section (1) of section 19 of the Principal Act, the following words and commas shall be omitted, namely:—

“, either by himself, or through any member of his family,” and “or any member of his family,”.

Amendment of section 20 of Assam Act I of 1957. 8. In section 20 of the Principal Act, in sub-section (1) the following words shall be omitted, namely:—

“either by himself or through any member of his family”.

Amendment of section 22 of Assam Act I of 1957. 9. In sub-section (1) of section 22 of the Principal Act, the following words and commas shall be omitted, namely:—

“either by himself or through any member of his family,” and “or any member of his family,”.

Amendment of section 23 of Assam Act I of 1957. 10. In clause (b) of section 23 of the Principal Act, the following words shall be omitted, namely:—

“or any member of his family”.
