THE ASSAM COLLEGE EMPLOYEES (PROVINCIALISATION) (AMENDMENT) ACT, 2020

#### ACT

further to amend the Assam College Employees (Provincialisation) Act, 2005.

#### Preamble

Whereas it is expedient further to amend the Assam College Employees (Provincialisation) Act, 2005, hereinafter referred to as the principal Act in the manner hereinafter appearing;

Assam Act No.XLVI of 2005

It is hereby enacted in the Seventy-first Year of the Republic of India as follows:-

# Short title, extent and commencement.

- (1) This Act may be called the Assam College Employees (Provincialisation) (Amendment) Act, 2020.
- (2) It shall have the like extent as the principal Act.
- (3) It shall come into force at once.

## Amendment of Section 8A.

2.

In the principal Act, in section 8A, after the existing provision, the following proviso shall be inserted, namely:-

"Provided that the period of six months, within which the Government's share of Contributory Provident Fund was required to be refunded in respect of the retired/deceased employees under section 8 which was further extended for a period of six months under this vide the Assam College Employees section, (Provincialisation) (Amendement) Act, 2010, hereinafter referred to as the Amendment Act, 2010, shall further be extended for a period of six months from the date of commencement of the Assam College Employees (Provincialisation)(Amendment) Act, 2020, hereinafter referred to as this Amendment Act, and the intervening period from the date of expiry of the period of six months extended under the Amendment Act, 2010, till the date of commencement of this Amendment Act, shall also be deemed to have been extended for the purposes of Section 8."
