THE ASSAM SECONDARY EDUCATION

(PROVINCIALISATION) (A:MENDMENT) ACT, 1996.

further to amend the Assam Secondary Education (Provincialisation) Act, 19 7.

Preamble. Whereas it is expedient further to amend the Assam Secondary Education (Provincialisation) Act, 1977, hereinafter referred to of 1977. as the Principal Act, in the manner hereinafter appearing;

It is hereby enacted in the Forty-seventh year of the Republic of India as follows: -

extent and commencement.

- 1. (1) This Act may be called the Assam Secondary Education (Provincialisation) (Amendment) Act, 1996.
- (2) It shall have the like extent as the principal Act.
- (3) It shall be deemed to have come into force on the 12th day of December. LEGISLATIVE DEPARTMENT: LEGISLATIVE PRANCH

Amendment of section-2.

- 2. In the principal Act, in section 2, -
- (i) in clause (ii), after the existing provisions, the following proviso shall be inserted namely :-

"Provided that for the purpose of pay and allowances as Government servant the date of appointment means the date of issue of the Notification provincialising the services of the employees of the respective school"

- (ii) for existing clause (xi), the following shall be substituted, namely:-
- "(xi) 'Secondary School' means a School where secondary education is imparted and is covered by deficit or ad-hoc system of grants-in-aid.

Insertion of section 3A.

3. In the principal Act, after section 3, the following shall be inserted as section 3A namely: -

"Provision School Reeceiving ad-hoc

- 3A. In respect of the Secondary Schools in respect of which have not come through the state of deficit schools the employees of the Secondary Schools receiving ad-hoc grant-in-aid grant in-aid shall be deemed to have become the employees of the State Government of Assam with effect from the date of Notification issued by the Government Provincialising the services of the employees of the said, schools on the same terms and conditions as provided in section 3."
- Repeal and 4. (1) The Assam Secondary Education (Prosaving. vincialisation) (Amendment) Ordinance, 1996 is hereby repealed.
  - (2) Notwithstanding such repeal, anything done or any action taken under the Ordinance so repealed shall be deemed to have been done or taken under the corresponding provisions of this Act.
