THE ASSAM MINISTERS', MINISTERS' OF STATE AND
DEPUTY MINISTERS' SALARIES AND ALLOWANCES
(AMENDMENT) ACT, 1995.

AN

ACT

further to amend the Assam Ministers', Ministers' of State and
Deputy Ministers' Salaries and Allowances Act, 1958.

Preamble. Whereas it is expedient further to amend the Assam Act,
Assam Ministers', Ministers' of State and Deputy XV of 1958,
Ministers' Salaries and Allowances Act, 1958,
hereinafter referred to as the principal Act, in the
manner hereinafter appearing;

It is hereby enacted in the Forty-sixth Year
of the Republic of India as follows :—

Short title
and com-
mencement. 1.(1) This Act may be called the Assam Ministers'
Ministers' of State and Deputy Ministers' Salaries and
Allowances (Amendment) Act, 1995.

(2) It shall be deemed to have come into force on
the first day of April, 1994.

2. In the principal Act, in section 2.—

Act, XV of
1958. (i) in clause (A), in sub-clause (vii), for the existing
provisions, the following shall be substituted, namely :—

“(vii) for journeys by road in his own or allotted car
within the State, Chief Minister shall be entitled to mileage
allowance at such rates as may be provided in the rules.”

(ii) in clause (B), in sub-clause (vii), for the existing
provisions, the following shall be substituted, namely :—

“(vii) for journeys by road in his own or allotted car
within the State, each Minister shall be entitled to mileage
allowance at such rates as may be provided in the rules.”

(iii) in clause (C), in sub-clause (vii), for the existing
provisions, the following shall be substituted, namely :—

“(vii) for journeys by road in his own or allotted car
within the State, each Minister of State shall be entitled to
mileage allowance at such rates as may provided in the rules”

(iv) in clause (D), in sub-clause (vi), for the existing provisions, the following shall be substituted, namely:—

“(vi) for journeys by road in his own or allotted car within the State, each Deputy Minister shall be entitled to mileage allowance at such rates as may be provided in the rules.”
