THE GUWAHATI MUNICIPAL CORPORATION  
(SECOND AMENDMENT) ACT, 1994

AN  
ACT

further to amend the Guwahati Municipal Corporation Act, 1969. Assam Act I of 1973.

Preamble. Whereas it is expedient further to amend the Guwahati Municipal Corporation Act, 1969, hereinafter referred to as the principal Act ;

It is hereby enacted in the Forty-fifth Year of the Republic of India as follows :—

Short title,  
extent and  
commence-  
ment.

1.(1) This Act may be called the Guwahati Municipal Corporation (Second Amendment) Act, 1994.

(2) It shall have the like extent as the principal Act.

(3) It shall come into force at once.

Amendment  
of section 4.

2. In the principal Act, in section 4, in sub-section (2), for the existing provisions of clauses (a) and (b), the following shall be substituted, namely :—

“(a) the Standing Committee ;

(b) the Ward Committee ; and

(c) the Commissioner.”

51, 52 and  
53.

3. In the principal Act, in sections 51, 52 and 53, the word, “Commissioner”, wherever it occurs, the words, “State Election Commission” shall be substituted.



Amendment  
of section  
54. 4. In the principal Act, in section 54,  
for the words, "the Commissioner", the  
following shall be substituted, namely:—

"an Officer authorised by the State  
Election Commission".

Amendment  
of section  
56. 5. In the principal Act, in section 56,  
in the first paragraph, for the word,  
"Government", the word, "State Election  
Commission" shall be substituted.

Amendment  
of section  
426. 6. In the principal Act, in section 426,  
in sub-section (1), in the end, after the  
word, "provided", for full stop ".", comma ",",  
shall be substituted, and after the comma  
so inserted, the following shall be inserted  
namely:—

"except making rules for matters referred  
under clauses (a) to (1) of sub-section (2)  
which may be made after consultation with  
the State Election Commission".
