WELFARE FUND (AMENDMENT) ACT, 1994.

AN ACT

further to amend the Assam Tea Plantation Employees' Welfare Fund Act, 1959.

Preamble -

Whereas it is expedient to amend the Assam Tea Plantation Employees' Welfare Fund Act, 1959 (Assam Act No.XVI of 1960), hereinafter called the principal Act, in the manner hereinafter appearing:

It is hereby enacted in the Fortyfifth Year of the Republic of India as

follows, namely:-

Short title, Extent and Commencement.

- 1. (1) This Act may be called the Assam Tea Plantation Employees' Welfare Fund (Amendment) Act, 1994.
- (2) It shall have the like extent as the principal Act.
- (3) It shall come into force on such date as the State Government may, by notification, in the Official Gazette, appoint.

Amendment of Section 2

- 2. (1) In the principal Act, in Section 2, in sub-section (2), the figure "500" appearing in the last line between the words "Rupees" and "per month" shall be substituted by the figure "1600".
- (2) For sub-section (10), the following shall be substituted namely— and average and avera
- "(10) "Wages" means wages as defined in Section 2(h) of the Minimum Wages Act, 1948 (Act II of 1948) or such wages/salaries as settled by any agreement/bilateral agreement between the management and the employees".
