THE ASSAM GENERAL SALES TAX (AMENDMENT) ACT, 1994

further to amend the Assam General Sales Tax Act, 1993.

Whereas it is expedient further to amend the Assam General Sales Tax Act, 1993, hereinafter referred to as the princi- Assam Act pal Act, in the manner hereinafter appearing:

It is hereby enacted in the Forty-Fifth Year of the Republic of India as

follows:—

Shorttide, 1. (1) This Act may be called the Assam extent and General Sales Tax (Amendment) Act. ment. 1994.

(2) It shall have the like extent as the principal Act

(3) It shall come into force at once.

Amendment of section 2 2. In the principal Act, in section 2, in of Assam Act clause (34), in sub-clause (d), in Explana-XII of 1993 tion 2 thereof, the words, "and charged to tax at the rate, if any, applicable to such goods", appearing at the end of the Explanation, shall be deleted.

Amendment of section 27 3. In the principal Act, in section 27, of Assam Actin sub-section (1), in clause (b), the word XII of 1993 "State" wherever it occurs, shall be deleted

Amendment of section 35 4. In the principal Act, in section 35, of Assam Actin sub-section (1), the words and figures XII of 1993. "under section 33, 34 or 36" appearing after the word "passed", shall be deleted.

Amendment of section 36
of Assam Act Explanation to sub-section (1) of section 36
XII of 1993. and just before the words "In the case of", the brackets and figure "(2)"
shall be inserted, so as to imply the paragraph as sub-section (2).
