further to amend the Assam Cooperative Land Mortgage Bank Act, 1960.

Preamble. Whereas it is expedient further to amend the Assam Cooperative Land Mortgage Bank Act, 1960, hereinafter (Assam Act referred to as the principal Act, in the I of 1961) manner hereinafter appearing;

It is hereby enacted in the Fortyfirst Year of the Republic of India as follows:—

Short title.

1. This Act may be called the Assam Co-operative Land Mortgage Bank (Amendment) Act, 1990.

"Whereas it is expedient to facilitate the working of Cooperative Agriculture and Rural Development Banks in the State of Assam with a view to providing for grant of long-term and short-term loans for the purposes of agricultural development and activities incidental thereto, to finance construction of houses in rural areas, to promote rural industrialisation by providing loans to artisans, craftsmen and small entrepreneurs and to advance loans to institutions and corporate bodies engaged in activities which directly or indirectly help the farmers and the rural people, in the manner hereinafter appearing;"
