THE ASSAM CONTINGENCY FUND (AMENDMENT) ACT, 1986

further to amend the Assam Contingency Fund Act, 1950.

Whereas it is expedient to amend the Assam Contingency Fund Act, 1950, hereinafter called the principal Act;

It is hereby enacted in the Thirty-Seventh Year of the Republic of India as follows:—

Short title and commencement.

- 1. (i) This Act may be called the Assam Contingency Fund (Amendment) Act, 1986.
- (ii) It shall come into force at once and shall remain in force upto the 31st day of March, 1987.

Amendment 2. In the principal Act, to Section 3, of Assam the following proviso shall be added, Act IX of namely:—

"Provided that during the period of operation of the Assam Contingency Fund (Amendment) Act, 1986, a further sum of twenty-five crores of rupees shall be paid from and out of the Consolidated Fund of the State of Assam into the Contingency Fund."
