ASSAM ACT No. IX OF 1986

THE ASSAM MINISTERS', MINISTERS' OF STATE AND DEPUTY MINISTERS' SALARIES AND ALLO-WANCES (AMENDMENT) ACT, 1986.

> An Act

further to amend the Assam Ministers', Ministers' of State and Deputy Ministers' Salaries and Allowances Act, 1958.

Preamble.

Whereas it is expedient further to amend the Assam Ministers', Ministers' of State and Deputy Ministers' Salaries and Allowances Act, 1958, hereinafter called the principal Act, in the manner hereinafter appearing;

It is hereby, enacted in the Thirty-Seventh Year

of the Republic of India, as follows:

Short title and commencement.

- 1.(i) This Act may be called The Assam Ministers', Ministers' of State and Deputy Ministers' Salaries and Allowances (Amendment) Act, 1986.
- 2. It shall come into force on the Ist day of September, 1986.

- Amendment 2. In the principal Act, for Section 2, the of Section 2 following shall be substituted, namely:—
 - "2. Salaries of the Chief Minister, the Ministers and the Ministers' of State:—

There shall be paid per mensem;

- (a) to the Chief Minister a salary of three
- thousand rupees, (b) to each Minister a salary of two thousand seven hundred and fifty rupees, and
- (c) to each Minister of State a salary of two thousand and five hundred rupees."
