THE ASSAM LEGISLATIVE ASSEMBLY MEMBERS' SALARIES, ALLOWANCES AND PENSIONS (AMENDMENT) ACT, 1986

further to amend the Assam Legislative Assembly Members' Salaries, Allowances and Pensions Act, 1958 (Assam Act XIV of 1958).

Preamble.

Whereas it is expedient further to amend the Assam Legislative Assembly Members' Salaries, Allowances and Pensions Act, 1958, hereinafter called the principal Act, in the manner hereinafter appearing;

It is hereby enacted in the Thirty-seventh Year of the Republic of India, as follows:—

Short title and commencement.

- 1. (i) This Act may be called the Assam Legislative Assembly Members' Salaries, Allowances and Pensions (Amendment) Act, 1986.
- 2. It shall be deemed to have come into force on the first day of April, 1986.
- Amendment 3. In Section 2 of the principal Act, the existof Section 2 ing section shall be renumbered as sub-section (1),
 Act XIV of and thereafter the following shall be inserted as
 1958. sub-section (2), namely:—
 - "(2) 'Constituency' shall mean the Constituency from which the member has been elected to the Assam Legislative Assembly."

Amendment of Section 3 of the principal Act, for the of Section 3 of Assam words "six hundred rupees per mensem," the words "rupees one thousand per mensem" shall be substituted.

Amendment of Section 4 of Assam Act XIV of 1958.

- 5. In Section 4 of the principal Act—
- (i) in sub-section (1) for the words "rupees forty-five", the words "rupees fifty" shall be substituted.
- (ii) for sub-section (3), the following shall be substituted, namely:—
- "(3) a constituency allowance of rupees five hundred per mensem for the purpose of tours in the constituency of the member to be drawn in the same manner as is prescribed for drawal of salaries in a separate form to be prescribed by rules made by the State Government in this behalf".
- (iii) after sub-section (3), the following shall be inserted as sub-section (4), namely:—
- "(4) a fixed monthly contingency allowance of rupees one thousand for meeting expenses on stenographic and typing assistance, postal services and subscription of newspapers."
