The Hon'ble the SPEAKER: After the development that took place on Tuesday last in consequence of a no-confidence motion that came up before the House, the present Ministry resigned, and the hon, members are perhaps aware that no new Ministry has yet been formed and that fact is proved by the presence of the Hon'ble Ministers, who resigned, in their seats But I may tell the House that the Leader of the Opposition has been called upon by His Excellency the Governor to form the Ministry and he has been given reasonable time for it. So far as the business of to-day is concerned, I must draw the attention of the hon, members to the fact that although the Hon'ble Ministers are in their seats to-day, they cannot function here in regard to questions and resolutions that are fixed for to-day and, therefore, I have not asked the Office to lay on the table of the members the answers to unstarred questions. If the hon, members wish to go on with the questions they may do so, but I must point out to the hon. members that no useful purpose would be served because with regard to answers to unstarred questions the Hon'ble Ministers cannot answer the supplementary questions that may arise from the answers that are laid on the table and also with regard to the starred questions they are in a similar position. So I wish to know whether the House want to put questions. With regard to resolutions also the Hon'ble Ministers will not be able to take any part and lay before the House Government views. So, if the House do not like to go on with the questions or resolutions to-day I must adjourn the House. The hon, members know that to-morrow and day-after to-morrow are fixed for Government business and I wish to know from Sir Muhammad whether for Government business and whether under these circumstances Government business can be transacted on these two days.

Of course, let us all hope that by that time a new Ministry would come into existence, whoever may form it, but the Leader of the Opposition has undertaken to form it.
