UNSTARRED QUESTIONS

(To which answers were laid on the table)

Tezpur Municipality

Mr. BINODE KUMAR J. SARWAN asked:

85. (a) Is the Hon'ble Minister-in-charge of Local Self-Government aware that for the paucity of fund the Tezpur Municipality has not been able to remove the grievances of the people of Ward No. 1, specially of Kumargaon and Lalmati areas, who are suffering greatly for want of water supply, latrine and light?

(b) Is it a fact that the Tezpur Municipality applied for some fund to Government for improving the condition of the Tezpur Municipality?

(c) If so, for what amount?

(d) Do Government propose to sanction the said loan to improve the

condition of the Tezpur Municipality?

(e) Is the Hon'ble Minister-in-charge of Local Self-Government aware that the rates of house taxes and other taxes have lately been increased by the Tezpur Municipality?

The Hon'ble Maulavi ABDUL MATLIB MAZUMDAR replied:

85. (a)—This is possible. No specific demand for the provision of latrines has so far been made to Government.

(b) to (d)—The hon. Member is referred to the replies given to his questions [Unstarred Question No. 6. (a)—(c)] on the subject in this Session of

the Assembly.

(e) -Government are aware that there was revaluation of holdings in the Tezpur Municipality in September 1949. From the assessor's report, it appears that the taxes have been nearly doubled.

Social Adult Education

Dr. EMRAN HUSAIN CHAUDHURY asked:

86. Will Government be pleased to state the number of Centres opened in Assam under the Social Adult Education at present?

Srijut MAHENDRA MOHAN CHOUDHURY (Parliamentary Secretary) replied:

86.—One thousand one hundred and forty Centres have so far been opened, of which 501 are new and 639 are under the old Mass Literacy Scheme.

Boat Disaster in the Brahmaputra near Pandu

Srijut GAURI KANTA TALUKDAR asked:

87. Will Government be pleased to refer to the reply given to Unstarred Question No.156 (b) (i) to (iv) asked by the Questioner during the September Session of the Assembly, 1949 (vide Assembly Debates of 20th September at page 1057) on the subject of Boat disaster in the Brahmaputra near Pandu and state—

(a) Whether the report called for from the Deputy Commissioner of

Kamrup has been received?

(b) If so, what is that report?

- (c) Whether the persons responsible for the boat tragedy near Pandu have been detected?
- (d) If so, who are they and how they have been punished?

The Hon'ble Maulavi ABDUL MATLIB MAZUMDAR replied:

87. (a) & (b)—A judicial enquiry into the matter was made by a First Class Magistrate, Gauhati. A copy of his report is laid on the table. Some of the accused are still untraced.

The Boat Disaster at the Brahmaputra at Pandu on 10th June 1949

On 10th June 1949 the 3-Up Assam Mail arrived very late at Amingaon. Soon after the arrival of the train at about 5-30 p.m. some of the passengers went to the river side to board the country boat for crossing. The water level was very high at the time, and there was no rain and the weather was clear. It was at the time of sunset at about 6 p.m. the ill fated boat left the Amingaon bank with approximately 40 passengers on it. There was nothing wrong when the boat left the Amingaon bank. The river was calm and the boat proceeded smoothly waves and the water from the rising waves got into the boat. There were high in succession and as more water got into the boat it lost its balance and the boat sons managed to keep afloat by catching the bamboos on the sides of the boat and went to the bottom and never rose again and the others were washed away due to the strong current of the river.

Before the boat sank one Apachandra Mudai a boatman at the Pandu bank saw the plight of the boat when it was taken by the sudden storm. Anticipating danger he proceeded with one boat to render any help that might be needed by the ill-fated boat. The helmsman Jamuna Rajbhor of the ill-fated boat behave in a strange manner. As soon as Apa's boat came nearer to the other boat Jamuna Rajbhor pushed aside the other boat with his oar. He did so twice, one Gokul Chandra Sarma of Fancy Bazar v. as in the ill-fated boat. He recognised Apachandra and asked him to park the boat somehow by the side of the other boat—Apachandra some how managed to bring his boat nearer to the other boat for a few minutes when 4 or 6 persons jumped into the other boat and saved themselves. After some minutes Gokul Chandra Sarma could see the other boat sinking amidst heart rending cries of the passengers.

Just before sinking one Motor launch passed by the boat from Pandu to Amingaon. The passengers cried for help, but those who were in the boat

remained unmoved and they did not care.

Those who remained affoat were drifting down the current for nearly two miles and their cries attracted the villagers of Garigaon. It was getting dark

and the villagers succeeded in rescuing about 13 persons.

Those who died and remained untraced included Professor Dinesh Chandra Misra, M. sc., Mohendra Lahkar, Prosecuting Sub-Inspector of Gauhati Court, Nagendranath Sarma of Sandheli, Nalbari and a Muslim boy aged 10 years. About 20 persons lost their lives. The passengers in the boat mostly consisted of men, one or two women and a few children.

The ill-fated boat was very large, about 40 cubit in length and 6 cubit

breadth. There was no overloading at the time.

The accident was unforeseen but the behaviour of the helmsman was strange at the time. The crews of the steam launch also remain unmoved in spite of piteous cries from the persons of the ill-fated boat.

(c) and (d)—Jamuna Rajbhor, Helmsman of the ill-fated boat is being prosecuted under Section 304 (a), Indian Penal Code, in connection with the boat tragedy. The case is still sub-judice.

Srijut GAURI KANTA TALUKDAR: Do not Government consider it desirable to reward Apachandra Mudai who at the risk of his life went to save the lives of the passengers of the ill-fated boat?

The Hon'ble Maulavi ABDUL MATLIB MAZUMDAR: It will be considered, Sir.

Senior and experienced Veterinary Field Assistants

Srijut RAJENDRA NATH BARUA asked:

88. Will Government be pleased to state-

(a) Whether it is in the contemplation of Government to promote the senior and experienced Field Assistants to the post of Veterinary Sub-Assistants to be in charge of Veterinary Dispensaries?

(b) If so, how many such posts are to be created and when the posts will be filled up?

The Hon'ble Maulavi ABDUL MATLIB MAZUMDAR replied:

88. (a)—Government do not propose to promote the senior experienced Veterinary Field Assistants to the post of Veterinary Assistant Surgeons as they have got only preliminary training in Veterinary Science. (b)—Does not arise.

Holding of a Census before the next election to the State Assembly

Srijut DALBIR SINGH LOHAR asked:

89. (a) Do Government propose to hold a census in Assam before the next

election of members to the State Assembly?

(b) Do Government also propose to make a complete census, house to house, of indigenous persons of Assam having (i) no land and (ii) having lands not more than 5 bighas per capita in the family, immediately?

The Hon'ble Srijut BISHNURAM MEDHI replied:

89. (a)—The All-India Census is fixed to start in February and finish by 1st March, 1951. In the opinion of this Government the elections need not wait till after the census.

(b)—The matter is under consideration of Government.

Acquisition of "Stony Land" Hotel by Government

Srijut BHADRA KANTA GOGOI asked:

90. Will Government be pleased to state-

(a) Whether it is a fact that one "Stony Land" Hotel has recently been acquired by Government for providing accommodation to the Government Gazetted Officers at Shillong?

(b) If so, at what price the property has been acquired?

(c) How many officers can be accommodated there?
(d) The class of officers to be accommodated there?

(e) Whether any of the officers have been accommodated in this building?

(f) If so, the name and designation of such officers and the Department they belong?

(g) The conditions under which they have been accommodated?

(h) Whether a circular letter was issued by Government to all the offices and Heads of Departments inviting applications from Gazetted officers for this purpose?

(i) If so, the name of such offices?

(j) If not, why not?

(k) Whether it is a fact that none of the offices except the Secretariat office could know about such a circular?

(1) If so, what is the underlying motive thereof?

(m) Whether Government are aware that many of the officers of Government do not get suitable accommodation at Shillong.

(n) If so, what arrangements have been made by Government for accommodating them?

The Hon'ble Srijut BISHNURAM MEDHI replied:

90. (a)—Yes.

(b)—At a cost of Rs.1,73,982-11-0.

(c)—Five.

(d)—Government Officers of the status of Under-Secretaries and above.

(e)—Yes.

Number of failures in Intermediate Examinations

Maulavi ATAUR RAHMAN asked:

Srijut MAHENDRA MOHAN CHOUDHURY (Parliamentary Secretary) replied:

- (c)—No. There are practical difficulties. Besides, this is a matter for the University to consider and decide.

Provision of Sub-way and Ghat on the Dikrong River and construction of Hurmuty Diversion Road

100. (a) Are Government aware of the big gulf created by the Dikrong river at its crossing ghat during the last flood?

(b) Will Government be pleased to state, if any action has been taken by the Public Works Department to provide any other Sub-way and Ghat to avoid troubles during the next rainy season?

(c) Do Government propose to take immediate steps to complete the construction of Hurmuty Diversion road so that the communication from the North Lakhimpur Subdivision with the rest of the State may not be completely cut off during the rains?

The Hon'ble Rev. J. J. M. NICHOLS-ROY replied:

Srijut Anil Kumar Choudhury (formerly a Sub-Deputy Collector) now appointed as Assistant Political Officer, Abor Hills

Maulavi ABDUL HALIM asked:

- 101. Will Government be pleased to state—
 - (a) The total length of service of Srijut Anil Kumar Chaudhury (formerly Sub-Deputy Collector) now appointed as Assistant Political Officer, Abor Hills?
 - (b) The date of his appointment as Assistant Political Officer?
 - (c) Whether it is a fact that his grade now as Assistant Political Officer is equivalent to that of Extra Assistant Commissioner (Senior grade of A. C. S. II)?
 - (d) The last pay as Sub-Deputy Collector which he was drawing before appointment as Assistant Political Officer?

(e) The pay he is drawing now?

- (f) Whether it is a fact that Government by Notification No.GA.84/48/41, dated 22nd November 1949, replacing his services on his appointment as Assistant Political Officer at the disposal of the Government of Assam in A. C. S. II have in fact appointed him to the senior grade of the service, viz., Extra Assistant Commissioner?
 - (g) If so, what are the reasons that have led Government to depart from the distinct practice laid down with regard to promotion of the members of the junior cadre to senior grade?
 - (h) Whether Government are aware that such discrimination in promotion ignoring the legitimate claims of the many senior and efficient officers in this important branch of the Revenue administration has brought discontentment amongst them?

The Hon'ble Srijut GOPINATH BARDOLOI repled:

- 101. (a)—Six years 5 months on 15th March, 1950.
 - (b)-4th November, 1949.
 - (c)—Yes.
 - (d)-Rupees 190 per mensem.
 - (e)-Rupees 250 per mensem.
 - (f)—Yes, but only as a temporary measure.
- (g)--This was not a case of promotion; but appointments of Assistant Political Officers, were made by direct recruitments after consulting the Assam Public Service Commission who advertised for those posts.
 - (h)—Does not arise.

*Maulavi ABDUL HALIM: With reference to Question No.101(f), may I know, Sir, for what period he has got this temporary promotion?

The Hon'ble Srijut GOPINATH BARDOLOI: As stated in the answer, Sir, the appointment was as a temporary measure, but I cannot give now the period that he had been on this post as a temporary measure.

*Maulavi ABDUL HALIM: I want to know, Sir, when this gentleman is relieved from his present post whether he will revert to his old post or not?

The Hon'ble Srijut GOPINATH BARDOLOI: I think, Sir, this matter needs a little elucidation which I may give for the hon. Member's information. So far as services in this part of the country is concerned, this is Governor's responsibility; and what the Governor's Secretariat do is to ask for the services of people whom they consider to be able to carry out the duties in this difficult part of the country. So far as this particular officer is concerned, apart from his aptitude for work in such country, the Ad-hoc Committee for recruitment of the Government of India selected him as a person who could be tried in more responsible duties. I suppose, on the strength of that recommendation, the Assam Public Service Commission, who asked by the Governor's Secretariat to look into this matter, chose Mr. A. K. Chaudhury as Assistant to the Political Officer for performance of those duties. This is the history of his appointment. So far as fixation of his pay is concerned, I suppose some rules have been framed by the Finance Department regarding the delegation of these officers for working in those areas and it is according to that that his pay has been fixed.

Re: Statement of Hon'ble Mr. Santhanam, Minister of State, Government of India

Dr. EMRAN HUSAIN CHAUDHURY: With regard to the recent serious statements and counter statements, made between the Central Government and the Provincial Government in which all Assam is interested, have the Government received any reply to their letter to the Hon'ble Mr. Santhanam?

Presentation of authenticated schedule of authorised expenditure in relation to Supplementary Demands for Grants for 1949-50

Re: Statement of Hon'ble Mr. Santhanam, Minister of State, Government of India

The Hon'ble Rev. J. J. M. NICHOLS-ROY: Mr. Speaker, Sir, I have got the letter now, and am placing it before the House.

It is a Demi-official letter No. 267-HMS(0)/49, dated New Delhi, March 21, 1950. It reads as follows:—

"Dear Mr. Nichols-Roy,

Please refer to your telegram of 17th March and your letter of 18th.

You would have already received a copy of the extracts from the speech of Mr. Chaliha and my reply thereto.

I was taken by surprise when Mr. Chaliha made the charges of negligence and lack of foresight on the part of the Central Government with reference to the Shillong-Haflong-Churaibari road and the Churaibari-Agartala road. He also claimed to represent your views on these matters.

You know very well that so far as these two roads are concerned, my reply was a mere statement of fact.

You have only objected to the sentence "Assam is specialising in wasting public funds without gaining any benefit for itself". I only meant to say that the Assam Government, in spite of their experience regarding the Shillong-Haflong-Churaibari road, made the same mistakes regarding the Churaibari-Agartala road. I had not the remotest intention to cast any general reflection on the Assam Government. I appreciate, however, that the sentence you have quoted is liable to be misunderstood as casting a general reflection. I should have been more careful and wish to express my regret for the sentence to which you have taken legitimate objection. You may publish this letter if you think fit.

Dear Mr. Santhanam,

I thank you for your D. O. No.267-HMS(0)/49, dated the 21st March 1950, expressing regret for the expression you have made in Parliament against the Assam Government.

I have made my speech in the Assam Legislature, a copy of which I am sending to you by Air Mail in a separate cover.

It is very clear that you are confusing about the two roads—the Shillong-Haflong-Silchar-Churaibari road and the Churaibari-Agartala road. This latter road is not under my charge. It is dealt with by the Governor with the Chief Engineer. I as Minister of Public Works Department have had nothing to do with this road.

I request you to kindly read the whole speech of mine. It may be that you have not had time to study the different letters which passed between the Government of Assam and the Government of India. In your letter you said these words "I only meant to say that the Assam Government, in spite of their experience regarding the Shillong-Haflong-Churaibari road, made the same mistakes regarding the Churaibari-Agartala road". You would know that the Assam Government had nothing to do with this road.

Moreover, I do not know what you meant by the words "in spite of their experience regarding the Shillong-Haflong-Churaibari road". I wish you would make it clear what experience you refer to. Then I shall be able to give you a reply.

Government Resolution re Construction of Public Health Dispensary and Staff quarters at Nazira and Sibsagar in Sibsagar district and Tikrikilla and Parakhasia in Garo Hills etc.

The Hon'ble Srijut RAMNATH DAS: Mr. Speaker, Sir, I beg to move that the Assembly do approve the projects undertaken by the Government of Assam, for the construction of the Public Health Department Dispensary buildings and staff quarters at Nazira and Sibsagar in the Sibsagar District, Tikrikilla and Parakhasia in the Garo Hills District and Kamargaon, Daulasal and Barama in the Kamrup District and the expenditure of Rs.63,275 involved in that connection being met from the existing provision of Rs.72,500 made through schedule under "39.—Public Health Works" in the current year's budget for opening of five Public Health Department Dispensaries in the different Districts of the Province.

The explanatory notes* are clear and explained the needs for this. It says that the total expenditure thus involved in the aforesaid projects comes to Rs.63,275. No separate provision for this amount could be made in the Budget for 1949-50. A provision of Rs.72,500 exists in the current year's Budget for construction of five new Public Health Department Dispensaries in the State. As time is not opportune to take up any new projects by way of constructing new Public Health Department Dispensaries due to present financial stringency, Government have agreed to meet the expenditure of Rs.63,275 from the existing Budget provision of Rs.72,500.

*EXPLANATORY NOTES

Simaluguri and its adjoining villages in the Sibsagar District are found to be heavily infected with Kala azar requiring a fully-equipped hospital. As present financial position of the State does not permit opening of such a hospital Government have decided to open two Kala-azar wards—one to be attached to the Sibsagar Civil Hospital and the other to the Nazira Local Board Dispensary. Accordingly an expenditure of Rs.35,500 for construction of these two wards was sanctioned in February 1949. As time was very short, the work could not be taken up and completed during the last financial year and had to be carried on this year. The work has since been completed.

The expenditure of Rs.10,050 and Rs.6,200 were sanctioned in the latter part of 1947-48 and 1948-49 for construction of the Public Health Department dispensary buildings and staff quarters at Tikrikilla and Parakhasia respectively in the Garo Hills District. The work could not be taken up during the work due to constitute the hilling materials. Construction of the latter part of 1947-48 and be taken up during the years due to scarcity of building materials. Construction of these buildings was taken up this year and has since been completed.

An expenditure of Rs.9,500 was sanctioned in November 1917 for construction of the Dispensary buildings and staff quarters at Daulasal in the Kamrup District. The work was taken up that year but could not be completed for want of cement and C. I. Sheets and so an amount of Rs. 3,000 remained unspent. This amount has since been expended this year.

of Rs. 3,000 remained unspent. This amount has since been expended this year.

An expenditure of Rs.1,641 was sanctioned in February 1948 for construction of the Public Health Department Dispensary buildings at Kamargaon in the Kamrup District. This amount was quite inadequate due to enhanced rate of building materials and labour necessitating an additional amount of Rs,6,125. The work is expect d to be taken up and completed this year. The incidence of Kala-azar at Barama in the Kamrup District is on the increase. The existing shed at Jakaikhora (Barama which can barely accommodate 4 patients is managed by Mr. B. K. Bhandary, a private individual and hence improvement and extension to this shed at Government expense, is not desirable. It has therefore been decided to construct a separate shed near the Public Health Department Dispensary or at a convenient place at Barama at an expending near the Public Health Department Dispensary or at a convenient place at Barama at an expenditure of Rs. 2,400 to accommodate four more indoor Kala-azar patients. It is expected that the

work will be taken up and completed during the current year.

The total expenditure thus involved in the aforesaid projects comes to Rs.63,275. No separate provision for this amount could be made in the Budget for 1949-50.
