The opening balance of financial year 2024-25 is taken at (-)Rs.222.99 crores under Revised Estimates. The estimated closing balance under Revised Estimate of 2024-25 year is (-) Rs.2574.94 crores.

- RECEIPTS** :- The Budget Estimates for 2024-25 under Revenue Account placed the total receipt in the Consolidated Fund at Rs.111943.84 crores. The Revised Estimates under Revenue Account has now been placed at Rs.112205.34 crores. There is thus increase of Rs.261.50 crores . in Revised Estimates. The Budget Estimate for 2024-25 under Capital Account in the Consolidated Fund was Rs.31661.73 crores.The Revised Estimate under Capital Account has now been placed at Rs.45600.59 crores. This has increased the Capital Receipts by Rs.13938.86 crore.
- EXPENDITURE** :- The Budget Estimates 2024-25 under Revenue Account from the Consolidated Fund was Rs.110091.86crores whereas the Revised Estimates has now been placed at Rs.117572.93 crores.

Taking into account the opening balance of (-)Rs.222.99 crores, the year 2024-25 under Revised Estimate is anticipated to close at (-) Rs.2574.94 crores as against (-) Rs.774.47 crores of the Budget Estimates of the year 2024-25.

The net result of estimates in public account transactions indicates a surplus of Rs.2511.07 crores during the year 2025-26.
