Chapter – I Grant No 35

The Departmentally Related Standing Committee on Development (D) Departments took Grant No. 35 incorporated in the Budget which was presented to the House on 10th March, 2025 for the Financial Year, 2025-26 for consideration.

1.1 While examining the papers and documents, as received from the concerned Department in respect of Grant No. 35 and the budget provision made thereto, the Departmentally Related Standing Committee on Development (D) Departments held the said meeting on 13th March, 2025 and took oral evidence from the Departmental representatives for discussing all the points raised by the Hon'ble Members of the Committee. CHAPTER II

2.1 ASSAM SKILL DEVELOPMENT MISSION (ASDM)

Assam Skill Development Mission (ASDM), as the nodal agency for skill development in Assam, is working under the aegis of Skill, Employment & Entrepreneurship Department, Government of Assam. ASDM provides quality skill training for gainful employment of unemployed youth, to encourage development of entrepreneurs in different sectors and to create a skills ecosystem for convergence of quality skills training. ASDM was formed in December, 2015, and it started Skill training from December, 2017.

2.2 Some major initiatives undertaken by the mission in creation of the skill ecosystem and in skill development areas follows:

- 1. State funded Placement Linked Skill Development Training Program (PLSDTP).
- 2. Central funded scheme Pradhan Mantri Kaushal Vikas Yojana (PMKVY) CSSM.
- 3. State funded The North East Skill Centre (NESC).
- 4. Central funded scheme Skill Acquisition & Knowledge Awareness for Livelihood promotion (SANKALP)
- 5. Central funded scheme National Urban Livelihood Mission (DAY-NULM).
- 6. Central funded PMKVY-RPL (CSSM).
- 7. Pradhan Mantri Anusuchit Jaati Abhyuday Yojna (PM-AJAY)-Sponsored
- 8. Deen Dayal Divyangjan Punorsansthapan scheme-Sponsored

2.4 DIRECTORATE OF EMPLOYMENT & CRAFTSMEN TRAINING, ASSAM

The Directorate of Employment & Craftsmen Training, Assam has two wings namely -

- (A) Employment Wing
- (B) Craftsmen Training Wing:
- (A) Employment Wing: The Employment Wing of the Directorate has a network of 52 nos. of Employment Exchanges spread across the state of Assam. The Employment Exchanges work under the ambit of the National Employment Service (NES) Manual along with

National Career Service for delivery of services like Registration of Jobseekers, Vocational Guidance & Career Counselling, Employment Market Information, Peripatetic Survey, Enforcement and Implementation of Employment Exchanges (Compulsory Notification of Vacancies) Act, 1959 and other various services under the provisions laid down thereon in the relevant rules. There are 2125998 nos. (as on 31st January, 2025) job seekers registered in the Employment Exchanges of Assam through Online Registration system in Sewa Setu Portal. Three services are available in Sewa Setu Portal – i) Registration, ii) Re-registration and iii) Renewal.

Notable major achievements of the Employment Wing of the Directorate of Employment & Craftsmen Training, Assam are: -

Mega Career Counseling Program me cum Career Fair:

On February 2, 2024, the Directorate of Employment & Craftsmen Training (DE&CT), under the Skill, Employment & Entrepreneurship Department, Government of Assam, organized a **Mega Career Counselling Programme** to guide students in choosing the right career path. Further steps undertaken by the respective Departments are as follows:

- ➤ Setting up of Model Career Centres (MCC) under National Career Service (NCS)at Guwahati, Jorhat, Nagaon, Silchar, Haflong, Diphu, Goalpara, Mangaldoi, Tezpur, Morigaon and Kokrajhar. The activities have already been started in these MCCs as per the norms and guidelines of National Career Service Project, a Govt. of India initiative.
- National Career Service Project (Mission Mode Project for Interlinking of Employment Exchanges) and the scheme aims to upgrade the infrastructure across all Employment Exchanges and to enable our region's youth to connect with employers all over the country. An amount of Rs. 31,877,988.00/- was utilized under this scheme for 44nos of Employment Exchange (under the General and Hill Area).

(B) <u>Craftsmen Training Wing</u>: Under the <u>Craftsmen Training Wing</u>, Vocational Training is provided in the Industrial Training Institutes (ITIs) and in Industrial Establishments through the Apprenticeship Training Scheme.

Main functions of Craftsmen Training:

- Admission into trades recognized by the National Council of Vocational Training (NCVT) and State Council of Vocational Training (SCVT)
- Conduct and evaluate training program me as per NCVT norms.
- Trade Testing and Certification.
- Apprenticeship training under Apprentices Act, 1961.
- Affiliating institutes as per prescribed NCVT norms.
- Facilitating placement of ITI pass-outs.

ASDM has been formed in December, 2015, and has started functioning since 2017.
- 2.INTRODUCTION: Assam Skill Development Mission (ASDM) was registered under Societies Registration Act XXI of 1860 in the month of December, 2015 for capacity building of the unemployed youth and to deliver quality skill training leading to meaningful employment.

ACTION TAKEN REPORT

Furnished by the Skill, Employment & Entrepreneurship Department on the observation and recommendation contained in the First Report of the DRSC on Development (D) Departments on Grant No. 35 of the Budget 2024-25

Recommendations	Action Taken
While discussing with the representatives Committee observes that there are insufficient numbers of Skill Development Centers in different Legislative Assembly Constituencies across the state causing increasing number of unskilled and unemployed youth in the state.	As per Hon'ble Cabinet Decision on setting up of ITIs at unserved Blocks of the State for providing vocational training to the youth of Assam, 27 nos. of ITIs were already covered under the PPP mode where in the ITIs were taken over by the eligible training partners (selected through RFP) on as is where is basis and for another 53 nos. of ITIs, RFP has been floated for selection of Private partner to establish, operate and maintain (O&M) on as is where is basis.
Therefore, the Committee recommends that the concerned department should establish at least one Skill Development Centre in every Constituency of the State for providing vocational training to the youth of Assam. The Committee was of the opinion that in the pursuit of this goal, the concerned Department should consult and avail guidance and/or assistance of the respective Legislative Assembly Member of the concerned Constituency.	Assam Skill Development Mission is providing short term Skill Development Training through various Training Provider (TP) ASDM empanels TP for establishing Skill Development Training Centre through private players in every district as per availability of fund or schemes recommended by State or Central Govt. ASDM would follow necessary steps in consultation and guidance of respective Legislative Assembly Member to ensure that the Training Centers are opened covering all the Legislative Assembly Constituencies across the state for providing vocational training to the youth of Assam
During the discussion with the representatives Committee observes that the existing ITIs to be strengthened in terms of infrastructure, manpower and tools and equipment to impart quality training in ITIs. On similar lines as done under the Centre of Excellence projects of MIS TTL & L&T projects the existing trades of ITIs need to be revamped and strengthened as per latest NSQF curriculum. Therefore the Committee recommends for adequate budget provision for rupgradation of the existing trades in the ITIs.	 i. The Department has initiated steps for modernization of ITI infrastructure as per the latest industry demands and the NSQF curriculum prescribed by DG(T), Govt. of India. From the State, funds State of Art Workshop to meet the quality in training standards as per NCVT affiliation norms. Tie-up have been made with Industrial establishments for support in enhancement of training infrastructure, up gradation of lab facilities in ITI's by installing new equipment, machinery, developing of technology tools relevant to course curriculum for new and emerging trades. "Samsung Technical School" setup at ITI,Guwahati in collaboration with M/s Samsung India Electronics Pvt. Ltd., Digital Classroom has been set up at ITI Srikona, Silchar with the support of ONGC. Electrical workshop at ITI Nagaon has been upgrade by Havells. Mechanic Motor Vehicle (MMV) Workshops have been upgraded at ITI Tezpur by Maruti, at ITI Nagaon and ITI Tinsukia by Tata Motors. Similar tie-ups with other Organizations/ PSUs for operationalization of some of the new ITIs and also for upgradation of trades are under process. ii. ii) PSUs have come up for development of the ITIs by direct participation. NRL as Industry partner and Chairman of Institute Management Committee for ITI Jorhat, ITI Golaghat and ITI Majuli, NEEPCO for ITI Haflong, IOCL, Bongaigaon Refinery for ITI Bongaigaon, BCPL for Dibrugarh, Oil India Limited for ITI Lahowal. iii. ITI's have been upgrading and strengthening their skill training facilities by setting up of State of Art workshops and by introduction of new trades. Some of the new trades introduced are- a) Fire Technology and Industrial Safety Management

- b) Bamboo Works
- c) Digital photo grapher
- d) Multi Media Animation and Special Effect
- e) Soil Testing and Crop Technician
- f) Fashion Design & Technology
- g) Painter(General)

- i) IOT Technician(Smart City)
- j) IOT Technician(Smart Healthcare)
- iv.)MoA has been signed with LEARNHILL FOUNDATION on 20t October'2023 for up gradation of the IT infrastructure and skilling of trainees of ITIs of Assam, providing 21st century skill training such as Electronics, Coding, Robotics, AI and 3D Printing leading to better employment of trainees. For the 1st Phase, training has been started in ITI for Women Guwahati.
- V.) 3 (Three) nos. of Solar and Electrical Training Centre's have been established in four ITI s by Sri Sri Rural Development Program Trust with the collaboration of Schneider Electrics.
- vi.) For up-gradation of the training infrastructure of the Govt it is aproposal for around Rs 200 Crores was submitted to Govt.
- A. The Cabinet has approved setting upof ITIs in the State through Private Sector participation. Provisions for establishing ITI with minimum 4 trades by utilizing unused buildings of different Govt. Departments providing Land, Self-financed idea and Budget provisions for 2023-24 has been proposed for providing scholarship to all students who take admission in all such Private it is to be run under PPP Mode. This policy for encouraging establishmentof ITIs in PPP Mode aspires to achieve the target of covering 160 un-served Blocks in the State and fulfill State Govt.'s mandatetoprovideaccesstoTraining opportunities to all.

OBSERVATIONS AND RECOMMENDATIONS

Grant No. 35

Skill, Employment & Entrepreneurship Department

After a great deal of careful consideration of the papers/documents submitted by the Skill Employment & Entrepreneurship Department and clarification made by the Departmental representatives during the course of tendering their oral evidence the Departmentally Related Standing Committee (DRSC) on Development (D) Departments has made the following Observations and Recommendations.

1. The Departmentally Related Standing Committee (DRSC) on Development (D) Departments observes that the Tools and Equipment available for various core trades in the ITIs of Assam were procured long back. As pass-out trainees must meet the current industry requirements, it is essential to upgrade the existing tools and equipment and install modern machineries in ITIs in line with present industry standards. Moreover, in case of some trades which are currently running under SCVT, these Tools and Equipment are required to be upgraded for getting NCVET affiliation.

The Committee, therefore, strongly recommends that the provision for supplementary funding may be made for procurement of such Tools and Equipments. Additional Budget allocation may be proposed by the respective Department amounting to Rs. 25 crores through SD to take up the upgradation process phase wise.

 The Committee makes the observation that to ensure smooth conduct of training at ITIs, the vacancies arising due to instructor retirements require urgent attention, as they are significantly impacting in imparting training in the institutes.

The Committee, therefore, recommends strongly that the Department should take necessary steps to enhance manpower/instructor engagement with a systematic approach, if required, may also go for additional post creation, keeping in mind the significance of the Department in curtailing unemployment issue for the youth by creating/training job opportunities etc.

3. The Committee makes the observation during the meeting that Five Mini ITIs are currently operating with 170 contractual staffs, who were engaged in sanctioned contractual posts on a fixed-pay basis. However, considering the rising cost of living and increased prices of the essential commodities, their salaries need to be revised as per regular staff to ensure their retention.

The Committee, therefore, recommends that the Department should take up the matter and propose for urgent salary revision of the 170 contractual staffs in 5 MINI ITIs across the State as per the retention norms following the pay scale of the regular staffs, as applicable.

4. The Committee during the deliberation makes the observation that to enhance skill development infrastructure and optimize the utilization of existing resources, an initiative needs to be undertaken for the establishment of ITIs

under the Public-Private Partnership (PPP) mode in vacant government buildings in the unserved areas of the State. This will facilitate the expansion of vocational training opportunities while ensuring efficient use of available infrastructure.

Therefore, the Committee makes the recommendation that necessary steps may be taken to identify suitable locations, with a focus to activate the untouched/interior/rural areas, engage industry partners, and initiate the process for establishing ITIs under the PPP model with immediate effect for strengthening the Skill Development opportunities.

The committee observes that to provide skill training to the youth in areas where Jagannath Community and Skill Training Centres have been constructed in the first phase, provision for fund is required to enable skill development by using the already available infrastructure to outreach the Departmental mandate. This initiative may have the scope to empower skill development for 30 youth per centre, benefiting a total of 3,000 youth approximately from the respective areas.

Therefore, the Committee recommends that the Department concerned may take up for necessary proposal for an allocation of Rs. 5 crore through SD for imparting training in at least 100 such centers through Assam Skill Development Mission (ASDM).

The Committee makes the observation during the course of meeting that the Skill University at Mangaldoi is about to start functioning and there will be ample scope of employment generation accordingly.

So, the Committee recommends that the Department concerned should take necessary steps for absorption/engagement of local unemployed youth, at least in the Grade III and Grade IV preferably.

With these observations and recommendations as mentioned aforesaid, the Committee recommends that the Budget provision amounting to Rs. 34002.77 Lakhs during the financial year 2025-26 under the Grant No. 35 be accepted.

The Action taken on the report may be submitted to the Committee within 90 (ninety) days from the date of presentation of the Report to the House.
