## CHAPTER-II

### Grant No.55

## ENVIRONMENT AND FOREST DEPARTMENT

Forestry is a vital sector of the State and it is a very important component of social sector in terms of goods and services it delivers.

The forest & tree cover in Assam as per the latest assessment by Forest Survey of India (F.S.I.) is 36.09% (as per latest Report, 2021) of the geographical area both within and outside the notified forest areas. The concept of extension forestry initiated in the early eighties under State Plan has percolated down fairly in terms of extent of forest cover outside the notified forest areas.

The thrust areas identified by the Department are as below:-

- Conservation of areas having rich biodiversity.
- Arresting the trend of degradation of Forests and reverting the process by reforestation through various stake holders.
- Eviction measures in Forest land of Assam and erection of boundary pillars in vulnerable areas.
- Conservation and Management of Protected Area Network.
- Upgradation of Research and Development activities.
- Improvement in livelihood support system of forest dependent communities.

### **Mandate of the Department : -**

#### *a) Function, role and responsibilities of the Department :*

The mandate of the Forest Department is to manage the Forest, Forest produces and Wildlife of the State of Assam. The relevant constitutional framework at the backdrop of management of forest resources are briefly enumerated as follows:

### **The Constitution of India:**

**Article 48 A** one of the Directive Principles, which state that the State shall endeavor to protect and improve the environment and to safeguard the forest and wildlife of the country.

**Article 51 A** deals with the fundamental duties of citizens, which include the citizen's duty to value and preserve the rich heritage of our composite culture and to protect and improve the natural environment including forests, lakes, rivers and wildlife and to have compassion for living creatures.

**Article 246** points towards the Seventh Schedule of the Constitution, which enlists forest as one of the subjects in the Concurrent List on which both the Central and State Governments shall legislate upon.

**The Assam Forest Policy, 2004** has been adopted in the State of Assam in the line of **National Forest Policy, 1988**.

***c) Brief description of the schemes indicating the main objectives, components and beneficiaries :***

Forestry is a vital sector of the State and it is a very important component of social sector in terms of goods and services it delivers.

The forest and tree cover in Assam as per the latest assessment by Forest Survey of India (F.S.I.) is 36.09% (as per latest Report, 2021) of the geographical area both within and outside the notified forest areas. The forest cover is more than what the nations aspires to achieve as envisaged in the National Forest Policy, 1988. The concept of extension forestry initiated in the early eighties under State Plan has percolated down fairly in terms of extent of forest cover outside the notified forest areas.

The thrust areas identified by the Department are as below: -

- Conservation of areas having rich biodiversity.
- Arresting the trend of degradation of Forests and reverting the process by reforestation through various stake holders.
- Eviction measures in Forest land of Assam and erection of boundary pillars in vulnerable areas.
- Conservation and Management of Protected Area Network.
- Up gradation of Research and Development activities.
- Improvement in livelihood support system of forest dependent communities.

The above thrust areas have been the centre points behind the SOPD schemes which have been formulated and implemented during the period.

***Implementation mechanism:***

Most of the schemes of forest regeneration and conservation are implemented in a participatory framework involving Joint Forest Management Committees. Besides, continuous efforts are being made to involve line departments for better resource mobilization and implementation of the developmental schemes in forest areas considering increased inter-dependence of the forestry sector with other sectors of the economy.

***New initiatives and innovative steps taken by the Department to improve its functioning by increasing the use of information technology and/ or through any other reform measures :***

- a. Rapid Response Teams- Mobile Anti-depredation Squad (MADS) & Field Anti-depredation Squad (FADS) have been constituted at division level to tide-over the situation of increasing human-wildlife conflicts in the state.
- b. Toll Free No. 0361 2333253 (To address the Personal Grievances of General People)
- c. Man-Animal Conflict Toll Free No. 0361 2333253 (To gather information about the Man-Animal Conflict in different parts of Assam)
- d. Relative ranks of subordinate forest officers have been upgraded to bring parity with police in terms of pay and other allowances. Also the anomaly regarding the Assistant Conservator of Forests as Class-I service as per rules getting class-II pay for the last so many years has been removed.
- e. Amrit Brikshya Andolan was launched by the Hon'ble Chief Minister, Assam on 02/08/2023 and more than One Crore seedlings were planted in single day by the people of Assam on 17/09/2023 and during the run up to this day 10 Guinness World Records were created from 09/09/2023 to 17/09/2023.
- f. For creating awareness among the people for conservation of wildlife, new Wildlife Safari and Rescue Centre at Cachar and Dibrugarh are at nascent stage of establishment.
- g. Rapid Response Teams (RRTs) under the Territorial Divisions have been provided with Aranyak Response Vehicles (vehicle fitted with all necessary items required for anti-depredation activity and rescue of animals) for quick and better response to animal depredation instances.
- h. To enhance surveillance in forest areas especially those adjoining Border States, procurement of modern surveillance tools like drones is in progress.
- i. 3<sup>rd</sup> AFPP Battalion has been raised on 23<sup>rd</sup> march. 2023 with a strength of 1115 and recruitment of 820 constables has already happened with appointment letters issued on 26<sup>th</sup> May during 2023.
- j. To provide a State of the Art wildlife health and rehabilitation facility to the state, a project to establish Institute of Wildlife Health & Research at Dinjan with three satellite centers at Kaziranga, Manas & Tezpur is in progress.
- k. To create a State of the Art Zoo, proposal of ₹362.042 Cr is already submitted which is awaiting approval from the Cabinet.

### ***Human Resource Development***

1. The main strength of the Forest Department is the frontline staff working in the remote forests. Hence, the importance of training, both induction and in-service. Assam has two State Forestry Training Institutes, namely the Assam Forest School at Jalukbari and Assam Forest Guards School, Makum for training of the Foresters and Forest Guards respectively.
2. To counter smugglers and poachers who are armed with modern arms and weapon 48 constables of Forest Protection Force are given Commando Training.

***Any other matter which the Department would like to highlight in the report and which is not covered in any of the subject heads above :***

In order to increase the forest cover, conserve biodiversity, improve the livelihood support systems for forest dependent communities and capacity building in the forest department, the following Projects and Schemes are in various stages of implementation as mentioned below:

### **(I) Assam Project on Forest and Biodiversity Conservation (APFBC) Phase-II**

The “Assam Project on Forest and Bio-diversity Conservation” (APFBC) Phase-I, co-funded by the French Development Agency (AFD) and the State Government of Assam, covered the entire state of Assam in a phased manner. Activities under the APFBC, Phase-I were implemented by the Field Implementation Units comprising of 32 territorial divisions, 7 wildlife divisions and 13 social forestry divisions in the Forest Department of Assam. The Phase-I of the Assam Project on Forest and Biodiversity Conservation (APFBC) ended successfully on 31st of May, 2019. Two separate agencies, the AFC-IDCG India and the OKD Institute, separately conducted independent evaluation of the Phase-I of the APFBC. Based on the said evaluations, it was mutually agreed by the Government of Assam & AFD to have a Phase-II of APFBC.

The project vision is “*to enable sustainable forest and biodiversity conservation and management in Assam through multi-scale integrative planning and involvement of forest dependent communities in target areas and giving fillip to their livelihood activities through sustainable use of forest and non-forest resources*”.

The project budget amounts to a total of 55.72 M € (equivalent to INR 445.75 Cr.), comprising of 44.57 M € (INR 356.60 Cr.) loan component from the French Development Agency (AFD) and 11.14 M € (INR 89.15 Cr.) counterpart funding by the state Government of Assam. The project is planned to be implemented in the entire state of Assam from 2019-20 to 2023-24. The project has been extended till December, 2025.

***Project Components:***

The components of the project are:

- Component 1:**        **Conservation of Ecosystems** (Sustainable Forest Management) aimed at to carry out forest management activities in a sustainable way.
- Component 2:**        **Community Engagement** (Adding Value and opening markets / opportunities for forests and biodiversity goods and ecosystem services) aimed at to add value to goods and services generated by communities through sustainable use of forest and non forest resources.
- Component 3:**        **Institutional Strengthening of Forest Department** aimed at to enhance the capacity of the Assam Forest Department.

**(II) Compensatory Afforestation Fund Management and Planning Authority (CAMPA):**

The Ad-hoc CAMPA was set up in 2008 on the orders of Hon'ble Supreme Court of India. The Ministry of Environment, Forest & Climate Change, Govt. of India issued guidelines for establishment of CAMPA in States/UTs in 2009. Accordingly, Govt. of Assam established Assam State CAMPA in 2009.

Thereafter, Compensatory Afforestation Fund (CAF) Act was enacted in the year 2016 and CAF Rules was notified in the year 2018 by the Ministry of Environment, Forest & Climate Change, Govt. of India. The State Compensatory Afforestation Fund Management and Planning Authority (State CAMPA) was notified on 14<sup>th</sup> Sept. 2018 under CAF, Act, 2016. The Governing Body, State Level Steering Committee and State Level Executive Committee have been notified by the Govt. of Assam on 26<sup>th</sup> June, 2019.

**Aim and Objective of State CAMPA**

1. Compensatory Afforestation against diversion of forest land.
2. Plantation other than Compensatory Afforestation like Artificial Regeneration, Aided Natural Regeneration, Sal Coppice Management etc.
3. Soil Moisture Conservation.
4. Wildlife Habitat Management.
5. Construction of buildings and other infrastructure development work for protection of forest and wildlife management.
6. Research and Capacity Development.
7. Publicity and Awareness for protecting forest.

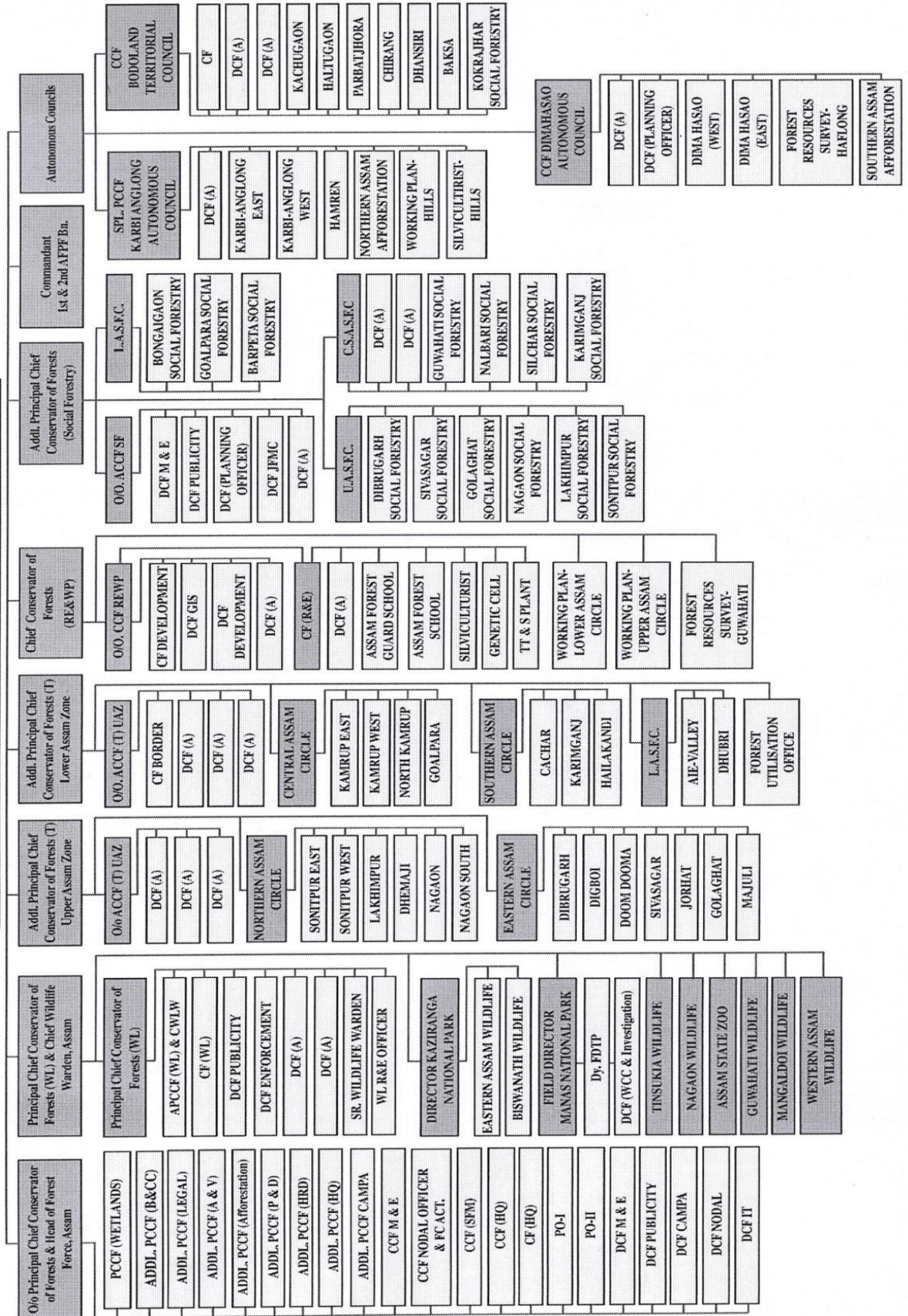
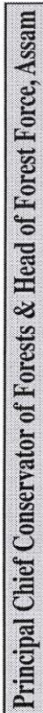

## **Action Taken Report on the Recommendations**

### **Action Taken Report on the Recommendations made by The DRSC in its Twenty Sixth Report (Grant No.55) of 2024-25**

**1. The Committee recommends the Department regarding the utilizing of forest materials for the departments like PWD (Roads), PWD (Buildings) Irrigation, PHE, Water Resources to inform the item wise requirements of forest materials provided in each and every works immediately after issuing work order to the contractor and provisions be made to deduct the amount of forest royalty from each bills by the DDO and the deducted amount of forest royalty be transferred to the Forest Department immediately.**

**Action:** On 24th April 2024 request was made to the State Government to take up the matter with concerned departments. [Enclosure at Annexure (i)]

**2. The Committee observed that the amount of existing compensation provided to the victims of Human Wildlife Conflict is not sufficient for the beneficiaries according to their damaged properties.**

**Therefore, the Committee reiterates that its earlier recommendation to increase the compensation amount for full financial support to the victims of Human Wildlife Conflicts.**

**Action:** On 1st June 2024 PCCF, Wildlife and CWLW proposed to enhance the ex-gratia amount provided by the State Govt. in line with the Central Govt. package issued by vide Office Memorandum F. No. WL-21/4/2023-WL dated 22-12-2023. The same proposal was sent to the State Govt. from this office on 06-06-2024 for taking necessary decision on the matter. [Enclosure at Annexure (ii)]

**3. The Committee observed that in Hailakandi district, monkey creates problems/disturbances to the inhabitants of the locality.**

**Therefore, the Committee recommends the Department to take necessary action steps for plantation of fruits base trees etc. for animals.**

**Action:** On 24th April APCCF (T), LAZ was requested to directed DFO concerned to take action accordingly on which APCCF directed DFO, Hailakandi Division to take suitable action on 03.05.2024. [Enclosure at Annexure (iii)]

**4. The Committee observed that in Hailakandi Reserve Forest, there are huge forest areas lying unutilized since long.**

**Therefore, the Committee recommends the Department to take necessary steps to survey of those lands and allow the local people for cultivation which will also help to promote greenery.**

**Action:** On 24th April APCCF (T), LAZ was requested to submit his views on which APCCF vide his office letter dated 04.05.2024 mentioned that as per existing rules and regulations, forest land cannot be allowed for cultivation by local people as recommended in the DRSC Report. [Enclosure at Annexure (iv)]

**5. The Committee reiterates its earlier recommendation to repair and renovate the Forest IB and Forest Rest House at Orang national Park.**

The Committee further suggests the Department for construction of a new Guest House at Orang National Park and takes up the matter with Forest and Tourism Department in this regard.

**Action:** As per recommendation made in 25th DRSC Report this office received estimate of ₹89.00 lakh for repair and renovation of Forest IB and Forest Rest House in Orang National Park from the DFO, Mangoldai Wildlife Division. The very same recommendation is made in the 26th DRSC Report and the estimate submitted by the DFO for recommendation made in the 25th DRSC Report is considered in the SOPD scheme during 2024-25 and placed before Govt. for necessary concurrence.

**6. The Committee reiterates its earlier recommendation to construct Forest IB at Hailakandi Matijuri Range and Jharbari under Haltugaon Division, Kokrajhar.**

**Action:** This office has received estimate of Rs.78.18 lakh for construction of Forest IB in Matijuri Range from the DFO, Hailakandi Division is considered in the SOPD scheme during 2024-25 and placed before Govt. for necessary concurrence.

**7. The Committee strongly reiterates its earlier recommendation to initiate plantation of Cane in large scale in forest areas of the State.**

**Action:** The Nagaon Wildlife Division has submitted estimate for strip plantation of cane in Laokhowa Wildlife Sanctuary under Gorajan Range which will be included in the management plan of the Wildlife Sanctuary during 2025-26.

**8. The Committee reiterates its earlier recommendation to construct two storied building with auditorium at Bamunigaon West Division (DFO office) at Bamunigaon under Chaygaon Development Block and also to speed up the construction work.**

**Action:** This office has received estimate of ₹298.00 lakh for construction of DFO Office from the DFO, Kamrup West Division is considered in the SOPD scheme during 2024-25 and placed before Govt. for necessary concurrence.

**9. The Committee observed that the Budget allocation for the Forest Department is not sufficient for smooth functioning of the Department.**

Therefore, the Committee recommends the Department to increase the Budget allocation for the Department.

**Action:** On 24th April 2024 request was made to the Govt. to take up the matter with the concerned department. [Enclosure at Annexure (i)]

**OBSERVATIONS AND RECOMMENDATIONS ON GRANT NO.55  
ENVIRONMENT & FOREST DEPARTMENT FOR THE YEAR 2025-26.**

1. The Committee recommends the Department to take necessary steps for controlling the menace caused by the squirrels and monkeys especially in Nalbari District.
2. The Committee recommends the Department to identify locations for construction of fencing in Manas National Park to prevent Men Elephant conflict.
3. The Committee recommends the Department to construct Elephant watch towers near Dhansiri River in Mazbat Constituency to enable the people residing near the river to take up agricultural activities without any disturbances from elephants.

Further the Department is recommended to process compensation for the people where their Crops has been affected by the destruction caused by the Wild Elephant at a speedy pace.

4. The Committee recommends the Department to construct Watch Towers in suitable areas to prevent Men & Elephant conflict and to make proper arrangements for training of 'Gaja-Mitra'.
5. The Committee recommends the Department to provide adequate compensation to people who are engage in horticulture activities (Tamul-Pan etc.) for destruction caused by elephants.
6. The Committee recommends the Department to increase the budget allocation for taking up infrastructure activities/developments activities including construction of camps/purchasing vehicles, watch tower etc. in all National parts of Assam.
7. The Committee observed that Bijni Bon Uddyan is one of the oldest park and is in a very dilapidated condition. The Committee therefore recommends the Department to renovate and also to undertake developmental activities for the upgradation of the Uddyan.
8. The Committee recommended to take necessary steps for construction of Forest IB at Gharmurah range, AFPPF camp at Kukicherra range and Community cum Forest Camp at Baruncherra under Kukicherra range.
9. The Committee recommends to take necessary steps for construction of Quarters for Forest Ranger at Matijuri Range and Range Head Quarter Kukicherra Range, Manipur area. It is further also recommended to construct Forest Beat Office at Ramnathpur under Gharmurah Range and quarters for the staff.
10. The Committee recommends to construct Forest IB at Lumding, Udalguri, Bijni, Pakabetkari, Hailakandi and Rangapara.
11. The Committee recommends the Department to undertake plantation projects of Barpeta Bhawanipur Road, Dangarkuchi Kaljhar Road, Kayakuchi Newlarbhitha Road, Rajaghat Bhaktardoba Road, Bhaktardoba to Sarthebari Road and Kayakuchi Jarabari Road to help promote greenary.

**The Committee recommends that the Budget allocation provided under Grant No.55 for the Financial Year 2025-26 for Environment & Forest Department be approved by the August House.**
