### CHAPTER 1 REPORT GRANT NO. 56 PANCHAYAT & RURAL DEVELOPMENT (PANCHAYAT)

After the presentation of the budget in the House for the financial year **2025-26 on 10<sup>th</sup> March, 2025,** the Departmentally Related Standing Committee on Development (A) Departments held in its meeting on **13<sup>th</sup> March, 2025** to discuss Grant No 56 relating to Panchayat & Rural Development (**Panchayat**).

Budget provision under Grant No.56 relating to the Panchayat & Rural Development (Panchayat) Department for the financial year, 2025-26 are as follows:

The amount so allocated is presented before the House and is proposed to be spent in the Revenue and Capital expenditure respectively.

While discussing the Budget provision for the year 2025-26, the Committee found that the Budget so allocated comparatively less than the previous Financial Year and there is no clear indication as to why the Budget allocation has been reduced.

The DRSC on Dev. (A) Departments in its sitting held on 13<sup>th</sup> March, 2025 examined papers and documents received from the concerned department and took evidence of departmental representatives. At the same time, the Committee considered the Action Taken Report on the recommendations made in its Twenty Sixth Report.

### CHAPTER 2 PANCHAYAT & RURAL DEVELOPMENT Brief Note Grant No.56

Panchayat & Rural Development Department strives for decentralization and empowerment of PRIs through various interventions. All the schemes of the Department are implemented through PRIs only. The NSAP and RGSA are major programmes being implemented by the Department. These programmes aim to improve the critical infrastructure in rural areas. The Old Aged Persons, Widows and Physically Challenged persons and National Family Benefit Programme will be provided monthly pension under the NSAP programmes. Panchayats will be strengthened through (RGSA) for better performance. Implementation of aforesaid are accepted to being socio economic changes in rural areas. Now, there are 3 (three) Component of each Scheme i.e. (101-Other), (789-SC) and (796-ST). Accordingly, Budget Provision has been provided in the respective Head of Account for the F.Y. 2025-26.

### PRELIMINARY STATUS RELATING TO GRANT NO. 56

During the year 2024-2025, the total outlay against Central Share and State Share is Rs.30069.44(L). For the year 2025-2026, Finance Department has allocated amount of Rs.6867.86 (L) as EE (non-salary) and an amount of Rs.13814.65 (L) is proposed under Revenue Head of Account and an amount of Rs.400.00 (L) under Capital Head of Account for purchase of vehicles for SOPD-G schemes (excluding Salaries & Wages). Out of which an amount of Rs. 6871.87(L)Budget provision under EE Non-salary and an amount of Rs.14214.65 (L) for SOPD-G (Revenue and Capital) as per allocation. However, an amount of Rs.46360.39 (L) as Central Share and an amount of Rs.1516.67(L) as State Share and an amount of Rs.14214.65 (L) (Revenue & Capital) has been proposed to provide in the budget 2025-2026 under Grant No. 56. Detail of which is given below.

1) NSAP (National Social Assistance Programme):- It was started by Govt. of India in 1995-96. Formerly this programme was implemented by the Social welfare Deptt. and from 2003-04, it was transferred to Panchayat & R.D. Deptt. It has four components like IGNOAPS, IGNWPS, IGNDPS& NFBS Schemes. During the year 2022-23, as per Govt. of India instruction for mapping of SNA Accounts separate budget provision has been made as (Others), (SC) & (ST) each component under NSAP scheme.

(a) **IGNOAPS** (Indira Gandhi National Old Age Pension Scheme):- The BPL people in age group of 60-79 years is given monthly pension @ Rs.200/- from the Central Assistance. The BPL people in the age group of 80 years and above is given a monthly pension of Rs.500/from Central Assistance. The present target is 695997 numbers.

(b) IGNWPS (Indira Gandhi National Widow Pension Scheme):- The BPL widow people in the age 40-79 years are given a monthly pension @ Rs. 300/- P.M. from Central Assistance. The present target is 119955 Nos. After attaining the age of 80 years and above, the beneficiaries are entitled to get Rs.500/- P.M.

(c) IGNDPS (Indira Gandhi National Disabilities Pension Scheme) :- Under this schemes, BPL disabled person in the age group 18-79 years is given a monthly pension @ 300/- P.M. from Central Assistance. The present target is 34579 Nos. After attaining the age of 80 years and above, the beneficiaries are entitled to get @Rs.500/- P.M.

(d) **NFBS** (National Family Benefitted Scheme) :- Under this schemes Rs.20,000/- is given as one time assistance to BPL family whose principal bread earner died prior to 1st April 2019 and an amount of Rs.25,000/- is given if the bread earner died on or after 1st April 2019. The age group of bread earner should be 18-59 years during the time of death.

During the financial year 2024-2025, an amount of Rs.34543.99(L) was provided as Central share. In the year 2025-2026, an amount of Rs.32710.39 (L) is proposed as Central Share under the NSAP Scheme.

2). **RGSA (Rashtriya Gram Swaraj Abhijan)** :-In order to ensure improved people centric Governance, responsive service delivery by Panchayats and attainment of Sustainable Development Goals (SDGs) by 2030, leadership capabilities of Elected Representatives and functional competencies of functionaries and awareness level of rural mass need to enhanced by many folds. With the above objectives, the Institute submitted a project proposal to the Ministry of Panchayati Raj with an amount of Rs.209.00 crores as per template given by Ministry of Panchayati Raj and the Govt. of India, The Government of India, Ministry of Panchayati Raj has already sanctioned an amount of Rs.71.66 crores to the State Government during the F.Y. 2024-25. As per timeline fixed by the Ministry of Panchayati Raj, the institute organized large number of training programmes for officials and other stakeholders on preparation of Gaon Panchayat Development Plan and attainment of Localizing Sustainable Development Goal.

3)  $6^{th}$  Finance Commission :- During the year 2024-2025, Govt. has budget provision for an amount of Rs.31121.88 (L). Out of the said amount an amount of Rs.5984.53 (L) was sanctioned but FOC not yet received. During the year 2025-2026 an amount of Rs.75891.78 (L) is proposed for providing in the budget to the Finance (E.A.) Department under  $6^{th}$  Finance Commission.

4) **15<sup>th</sup> Finance Commission** :- During the year 2024-2025, Govt. has provided an amount of Rs.124749.91 (L). Out of which, an amount of Rs.62219.17 (L) was incurred as expenditure at present. During year 2025-2026 an amount of Rs.219844.00 (L) is proposed for providing budget under 15<sup>th</sup> Finance Commission to the Govt.

5) **SOPD-G** :- During the year 2024-2025, Govt. has provided an amount of Rs.13814.66 (L) for Revenue and an amount of Rs.400.00 (L) for Capital for purchase of vehicles. Out of which, an amount of Rs. 13814.64(L) was incurred as expenditure for Revenue & no expenditure has been incurred for Capital at present. During year 2025-2026, an amount of Rs.13814.65 (L) is proposed under Revenue Head of Account and an amount of Rs.400.00 (L) under Capital Head of Account for purchase of vehicles under SOPD-G.

5.	The Committee observes that the proposal for construction of Staff quarters for Srijangram Blocks should be looked into and a complete proposal for all categories of staff may be incorporated. The Committee recommends to take up the matter of construction after the completion process of Delimitation undertaken by the Election Commission of India.	In accordance with the letter vide No. Tech.Br VII/106/20022/41, dated 20.07.2024, the Chief Engineer PWD (B) Department submitted a model estimate regarding construction of Block Office Building along with quarters for BDO, JE/Accountant, Chowkidar and Peon under SOPD and the same has already been approved by the Government in the Panchayat & Rural Development Department vide letter No. E-107939/466, dated 14.03.2024 . As a result, this Commissionerate is not in position to construct only staff quarters for Srijangram Dev. Block as there is no specific Head of Account or any guidelines for construction of only Staff Quarter sunder SOPD scheme It may be mentioned here that the matter is under process in the P&RD Department.

#### Grant No.56

#### **OBSERVATIONS AND RECOMMENDATIONS FOR THE YEAR 2025-26**

The Committee after holding a threadbare discussion and on close scrutinization of the report related to Grant No.56 of the Panchayat and Rural Development (Panchayat) Department on the evidences provided by the Departmental representatives made the following Observations and Recommendations.

1. During the course of discussion the Committee observes that there is insufficiency of Staff quarters in the Block offices of GP's.

The Committee recommends that all the staffs of Block offices should be allocated with sufficient nos. of staff quarters with special reference to Pakatbetbari, Ghilamari, Rupsi, Lumding and each district of Assam.

2. During the course of discussion, the Committee observes that some of the office buildings of Goan Panchayats in Assam are not properly constructed.

The Committee, therefore recommends for construction/renovation of the office buildings in all Goan Panchayats where necessary.

- 3. The Committee recommends that the vacancies of the post of Gram Rojgar Sevak (GRS) and SRS are to be filled up at an early date.
- 4. During the course of discussion the Committee observes that there are shortage of Computer Assistants in every Block Offices of Goan Panchayats.

Therefore, the Committee recommends that the nos of Computer Assistant to be increased in all Block Office of Goan Panchayats.

5. During the course of discussion the Committee observes that there is encroachment of land in market places.

The Committee, therefore recommends that evictions should be undertaken in the encroached market areas.

- 6. The Committee recommends the Department for construction of a building for Sahabad Block Development Office on the vacant land of Katlicherra irrigation sub-division at Sahabad.
- 7. The Committee recommends the Department to construct office building for Pub Betbari G.P., Madhya Betbari G.P., Dakshin Paka G.P., Paschim Betbari G.P., Uttar Betbari G.P. and Uttar Pub Betbari G.P.
- 8. The Committee recommends the Department to construct Staff Quarter at Pakabetkari Development Block.
- 9. The Committee recommends the Department to take measures so that the land of Kayakuchi Bazar, Bhatardoba Bazar and Barbala Bazar can be freed from encroachment.

The Committee recommends that the Budget allocation provided under Grant No.56 for the Financial Year 2025-2026 relating to the Panchayat and Rural Development (Panchayat) Department be approved by the August House.

During the year 2024-2025, the total outlay against Central Share and State Share is Rs.407957.94 (L).For the year 2025-2026, Finance Department has allocated amount of Rs.1277.14 (L) as EE (non-salary) and an amount of Rs.110355.38 (L) for SOPD (excluding Salaries & Wages). Out of which an amount of Rs.390.98 (L) Budget provision under EE Non-salary and an amount of Rs.109955.38 (L) for SOPD as per allocation. However, an amount of Rs.802517.00 (L) as Central Share and an amount of Rs.97470.78(L) as State Share and an amount of Rs.109955.38 (L) under SOPD-G (Revenue & Capital) has been proposed to provide in the budget 2025-2026 under Grant No. 57. Detail of which is given below.

- MGNREGA (Mahatma Gandhi National Rural Employment Guarantee Act.):- It is a Centrally Sponsored scheme for providing 100 days wages employment in a year to the unskilled job card holders who demand work. During the financial year, 2024-25 an amount of Rs.33830.82 lakh has been released out of allocation of Rs.91837.50 lakh against Central Share and Rs.11276.94 lakh was released against State Share out of allocation of Rs.30612.50 lakh. Further, an amount of Rs.1,52,268.73 lakh under Wage Component is released against 610.34 lakh person days by the Govt. of India directly to NeFMS account in the Commissionerate of Panchayat & R.D. For the year 2025-26 an amount of Rs.42330.00( L) is budgeted as Central Shareand Rs.14110.00 (L) as State Share as material component, an amount of Rs.8466.00 (L) as Admin. Component, an amount of Rs.634.77 (L) as CFP, an amount of Rs.7.47 as Project UNNATI.
- 2) PMAY-G (Pradhan Mantri Awas Yojona- Gramin) Formerly Indira Awas Yojona :-It is an important rural housing scheme of Govt. of India for rural B.P.L. households. It is a continuous Centrally Sponsored scheme and funded by Govt. of India and State Govt. in the ratio of 90: 10 basis. During the financial year 2024–2025, an amount of Rs.284926.22(L)released against Central Share and an amount of Rs.31658.47lakh was released as State Share. For the year 2024-25, an amount of Rs.684749.49(L) is budgeted as Central Share and Rs.76083.28 (L) as State Share.
- **3)** N.R.L.M. (National Rural Livelihood Mission):-Earlier S.G.S.Y. programme has now been restructured and renamed as National Rural Livelihood Mission (NRLM). The restructured programme is being implemented in a mission mode with a time bound and outcome based approach. The NRLM is a Centrally Sponsored Flagship Programme funded by Govt. of India and State Govt. on 90 : 10 basis. In the current year 2024-2025, an amount of Rs.30515.91 lakh has been released as Central Share out of budget provision of Rs.47810.00 lakh and Rs.3390.66 lakh has been released as State Share out of budget provision of Rs.5312.22 lakh. For the year 2025-26 an amount of Rs.65833.69 (L) is budgeted as Central Share and Rs.7133.50( L ) as State Share for implementation the ASRLM schemes.
- 4) S.I.P.R.D. (State Institute of Panchayat Rural Development):- During the financial year 2024-2025 an amount of Rs.195.80 (L) as Central Share was provided in the budget. An amount of Rs.27.00 (L) as the Central Fund was directly released to the CNA Account of SIPRD through NeFMS by the Govt. of India and an amount of Rs.44.00 lakh was provided in the Budget as State Share. For the year 2025-2026, an amount of Rs.195.80 (L) has been proposed as Central Share and Rs.44.00 (L) as State Share.
- 5) SOPD:- During the year 2024-2025, an amount of Rs.47455.99 (L) has been provided under Revenue and an amount of Rs.3585.00 (L) under Capital for the scheme under SOPD-G. Out of the said budget provision an amount of Rs.19982.37 (L) has been drawn & disbursed under Revenue and an amount of Rs.284.01.00 (L) under Capital at present. For the year 2025-26, an amount of Rs.92514.10(L) (Revenue)and an amount of Rs.17441.28 (L) (Capital) has been proposed to provide Budge for implementation of the scheme under SOPD-G.

### **BRIEF NOTE GRANT NO.57**

Rural Housing, job opportunity of Self Help Group etc. are in Major thrust area under Grant No.57. It is proposed to generate Rs.775.00 lakh man days under MGNREGA and PMAY-G houses are proposed to be constructed in the State in 2024-2025 as spill over activities. BPL families mainly women will be organized through SHG and they will be provided financial support and training under ASRLM. Landscape of rural economy is accepted to improve significantly through implementation of the aforesaid Schemes. Now, there are 3(three) Component of PMAY-G and NRLM Scheme i.e. (101-Others)(105- in case of PMAY-G), (789-SC) and (796-ST). Accordingly, Budget Provision has been provided in the respective Head of Account for the F.Y. 2025-26.

		Regarding completion of maximum numbers of works in NREGASoft, it has been monitored from the HQ through online and offline mode (i.e. VC and review meeting weekly) that districts should prioritize clearing material bills to facilitate the timely completion of a higher number of work under MGNREGA. In this regards, instructions has also been issued to the districts vide letter No. E- 407041/DFA/970545/I/873921/2024, Dated 27.12.2024. A notification was issued to all districts vide letter No. CPRD/MGNREGA/30/2022/43, dated 07.07.2023 regarding enhancement of percentage of expenditure for construction of all weather roads and pucca internal roads under Mahatma Gandhi NREGS and XV Finance Commission Basic (untied) Grants. As per this notification, 25% of total expenditure of the block can be made under MGNREGA and maximum upto 100% of untied grants of XV Finance Commission can be made for implementation of all weather pucca road. The implementation guideline and criteria of MGNREGA and Finance Commission is different. Therefore, a technical committee was formed at State level vide order No. No.E- 335502I/593993/2024, Dated 17.06.2024 to effectively explore the possibility abiding with guideline and plan for the construction of all- weather roads in convergence of MGNREGA and the 15th FC in compliance with the extant rules. However, the technical Committee suggested to construct all weather road in individual mode for both the programmes based on the SOPs issued mentioned above.
3	The Committee observes that the many of the PMAY-G houses in the state have been completed without providing 95 days of wage under MGNREGA due to which the beneficiaries have been deprived out the daily wages.	As per the communication from the Ministry of Rural Development, vide no: M-13011/01/2016- RH-Part(3)(376676), dated: 10th May, 2022, States and Union Territories can generate Muster Rolls (MRs) during the construction period to extend the benefits of 90/95 person-days unskilled wages through convergence with the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA).

The committee recommends to take up the matter with the ministry of Rural Development to allow providing 95 days of wages after completion of the PMAY-G houses. ### **OBSERVATION AND RECOMMENDATIONS FOR THE YEAR 2025-26**

The Committee after holding a threadbare discussion and on close scrutinization of the report related to Grant No.56 of the Panchayat and Rural Development (Rural Development) Department on the evidences provided by the Departmental representatives made the following Observations and Recommendations.

1. The Committee observes that in implementation of MGNREGA, the maximum ongoing work limit is fixed at 20(twenty) nos. per GP and due to non payment of material component most of the schemes are still shown as ongoing for which the GPs are unable to take up new schemes.

The Committee, therefore recommends to take necessary steps for increasing the ceiling limit of ongoing works and to pay MGNREGA on priority basis and also other bills with small amounts for increasing the number of work completion.

The Committee also recommends for convergence of MGNREGA with 15<sup>th</sup> Finance Commission in construction of CC Block Roads so that at least 500 mtr. Length of the village road can be covered.

2. The Committee observes that most of the PMAY-G houses in the state have been completed without providing 95 days of wage under MGNREGA, due to which the beneficiaries have been deprived from their daily wages.

The Committee, therefore recommends to take up the matter with the Ministry of Rural Development to allow providing 95 days of wages after completion of the PMAY-G houses.

3. The Committee recommends the Department to construct Ring Bunds on both sides of Pahumar river, Tihu river, Palla river, Kaldia river and Unnir Jan river to be covered under MGNREGA.

The Committee recommends that the Budget allocation provided under Grant No.57 for the Financial Year 2025-2026 relating to the Panchayat and Rural Development (Rural Development) Department be approved by the August House.
