

INTRODUCTION

CHAPTER-I**BRIEF REPORT (Building)**

1. **Construction of Convention Centre cum State Guest House at Guwahati, Assam**
Revised Administrative Approved Amount: **Rs. 4,77,31,49,000.00 (Rupees Four Hundred Seventy Seven Crore Thirty One Lakh Forty Nine Thousand only)**

Revised AA no. & Date: **AA/PWB_2024-25(I)_2375 dated 29-01-2025**

Executing Agency: **P.W.D (Building), Assam.**

Name of Division: **Medical Colleges & Hospitals Construction Division, Fancy Bazar-01.**

This tender based estimate, amounting to Rs. 4,77,31,49,000.00 (Rupees Four Hundred Seventy Seven Crore Thirty One Lakh Forty Nine Thousand only) has been prepared to reflect the probable cost for the work of "Construction of Convention Centre cum State Guest House at Guwahati, Assam." This estimate is based on the previously sanctioned provisions and the accepted L1 quoted rates.

The Administrative Approval (AA) for the project was initially accorded for ₹259,46,07,000.00 vide AA/PWB_2018_19(I)_284 dated 14/01/2019. The work was originally awarded to Shapoorji Pallonji and Company Pvt. Ltd., but the contract was foreclosed on 19/04/2024 after achieving a physical progress of 49.50 % as per instructions received from Govt vide letter no. E-443713/327 dtd. 01/04/2024.

Following the foreclosure, fresh bids for balance work were invited vide "Press Notice" No. I/594189/2024 dated Guwahati, 18/06/2024. To encourage wider participation, the deadline for submission of bids, originally set for 26/07/2024, was extended until 2:00 PM on 5/08/2024 vide No. I/657100/2024 dated 26/07/2024, as only a single bid had been received by the initial deadline.

Upon opening the financial bids, it was observed that the quoted prices exceeded the estimated amount put to tender (NIT value). Consequently, a review meeting, chaired by the Chief Secretary to the Government of Assam, directed the Public Works Department (Building) to explore cost-reduction measures for the project. Pursuant to this, an Expert Committee was constituted vide No. CE/TB- IV/02/2024/26 dated 03/09/2024 to identify potential areas for cost reduction while considering project requirements and visitor footfall.

The Expert Committee recommended modifications to the scope of work, including replacing granite/Italian marble cladding with double-charged vitrified tile cladding. These changes resulted in a cost reduction of ₹6,64,62,000.00, bringing the estimated cost put to tender to ₹249,02,22,967.00. The committee's findings and recommendations were submitted vide report No. CE/TB-IV/38/2022/63 dated 24/09/2024, which is enclosed herewith.

• A Negotiation Committee Meeting was also convened on 19/10/2024 based on Govt. Communication No. 561621/18 dated 16/10/2024. During the meeting, the L1 bidder, Shree Gautam Construction Company Ltd., was requested to justify their higher bid price and was apprised of the Expert Committee's recommendations regarding the reduced project scope and cost.

In their response, vide letter No. SGCCL/GHY/Convention Centre/2024-25/752 dated 19/10/2024, Shree Gautam Construction Company Ltd. expressed their willingness to accept the revised scope of work and offered a rebate. The revised bid price was as follows:

- Original L1 Quoted Bid Price: ₹351,00,00,000.00
- Cost Reduction Due to Scope Modifications: ₹9,12,43,686.00
- Rebate Offered by L1 Bidder: ₹7,00,00,000.00

Therefore, the final Revised Bid Price of the L-1 bidder: Rs. 334,87,56,314.00

The Scope of work includes:

1. Civil work
2. Plumbing, Drainage, sewerage & fire fighting system,
3. Electrical works
4. AV works
5. Telephone and data works
6. Lighting and automation
7. HVAC
8. Horticulture
9. Signage
10. Furniture work
11. 33kV incoming line from Grid substation to HT Metering Panel & Incoming (as per APDCL quotation)
12. Electrical load sanction and approval charges (as per APDCL quotation)

The balance work is allotted to Shree Gautam Construction company Ltd. on 17/02/2025

2. Upgradation of Kolkata Assam House at Salt Lake including areas and other amenities.

Two estimates namely (i)"Repair/Renovation of Assam Bhawan at Salt Lake (Construction of policebarrack including bunker bed &table, waterproofing treatment in damp wall, false ceiling works, interior painting of Assam Bhawan etc) for an amount of Rs. 39,49,324.00" and (ii)"Painting (Exterior) of Assam Bhawan, Salt Lake, Kolkata for an amount of Rs. 17,95,597.00" were sent to GAD vide no. CE/TB-IV/68/2019/34 dated 07/09/2022 and no. CE/TB-IV/189/2018/46 dated 19/02/2022 respectively for approval. In this regard, one justification report for necessity of the works along with photographic evidence was also submitted to GAD vide letter No.CE/TB-IV/68/2019/Pt/7 dtd. 4th Nov'2023.

On 28th May, 2024, Joint Secretary to the Govt. Of Assam, GAD, asked for fresh plan and estimate for the above mentioned work as those were prepared in the year 2021-22.

Therefore, one estimate for the work "Renovation/Refurbishment of Assam Bhawan, Salt Lake, Kolkata (including Providing ACP Board panel in the duct and window, Plastering of damaged walls with waterproofing treatment, outside painting Works with wall putty, replacement of AC stand, Changing of damaged outside floor tiles, Changing of Assam Bhawan letter both English and Assamese Language etc. amounting to Rs. 1,13,29,874.00 submitted to GAD vide no. CE/TECH-V/39/2024/37 dated 24/10/2024 for allotment of fund. In reply GAD has asked for separate estimate for each items vide no. GAD-478108/213 dated 18/12/2014 which was not feasible and that is why the estimate has been sent to Govt. In PWD (B&NH) vide no. CE/TECH-V/39/2024/39 dated 08/01/2025 for accord of AA.

Another estimate for the work "Restoration works of Assam Bhawan at Salt Lake amounting to Rs. 1,65,64,500.00 had been submitted to Govt. in PWD (B&NH) vide no. CE/TECHV/45/2024/30 dated 17/12/2024 for approval.

AA for both the works are awaited.

3. Construction of a Mini Stadium at Lanka under Hojai District: As per recommendation No. 14 of 25th Report of the DRSC on work Departments, Assam Legislative Assembly, the Committee reiterates its earlier recommendation No. 18 of 24th Report (202-24). In this regard, Executive Engineer, Hojai District Territorial Building Division, informed his letter No.EE/HDTBD-29/2023-24/1143 dated 03/04/2024 that correspondence has been made with Lanka Revenue Circle and District Administration for allotment of requisite suitable land (Approx.30.00 Bigha of land). One reminder draft issued vide no. T/TB-1/60/2023/25 dated 31.05.2024. Also concerned EE requested to the Circle Officer, Lanka Revenue Circle Officer to demarcate and hand over the 30 bigha plot of land recommended by the Hon'ble MLA, 63 Hojai LAC vide No.EE/HDTBD/T-78/2024-25/516 dated 31/07/2024. One reminder issued to EE to furnish up to date status regarding availability of feasible land vide 1/930181/2025 date 6.02.2025. However, till date no land documents are received from District Administration.

4. Construction of a Mini Stadium at Boko LAC: As per recommendation No 16 of 25th Report of the DRSC on work Departments, Assam Legislative Assembly. The E.E. Boko, Chaygaon&Palashbari Territorial Building Division has communicated with the District Administration for allotment of 50 Bigha of land for the Scheme vide his letter No. TB-43/BC&PTBD/2023-24/2558 dated 30/03/2024. Reminder drafts issued vide no. T/TB-1/60/2023/25 dated 31.05.2024 and 1/930181/2025 date 6.02.2025 to EE to furnish up to date status regarding availability of feasible land vide In response to T.O letter dated 6.02.2025, EE informed that necessary correspondence has been made to District Commissioner, Kamrup, Amingaon vide letter dated 30.03.2024 but till date no allotment of land is received from Concerned department and also once again requested District Commissioner, Kamrup, Amingaon, for allotment of land vide letter No.TB-43/BC&PTBD/2023-24/1866 dated 13.02.2025.

5. Construction of a Mini Stadium at Ulubari area of Bijni: As per recommendation no 20, the EE Kokrajhar District &Chirang District Territorial Building Division informed vide No. Tech-186/Misc/2022-23/60 dated 3/04/2024 that the land in favour of "Construction of Mini Stadium at Fulkumari (Ulubari) Bijni has already been allotted by the Circle Officer, Bijni Revenue Circle. However, till date estimate is not received from the concerned Division.

6. Construction of a Circuit House at Nazira: The District Commissioner, Sivasagar District was communicated by the Concerned EE,PWD, Sivasagar Dist. TBD vide No. B/118/93-94/1370 dtd. 08.04.2024 to allot sufficient adequate land for taking up the project. But, no land was handed over by the District Administration till date. In this regard, necessary process for engaging DPR Consultant was also initiated. However, same can be finalized only after receipt of sufficient adequate land for the project.

(i) Works Sanctioned under PWD (NH Works), Assam in the financial year 2024-25

A total of five NH (O) works has been sanctioned in the financial year 2024-25 so far, covering a total length of 77.75 km, with a total sanctioned amount of Rs. 201.23 Crore. This includes one Land Acquisition (LA) estimate for a length of 15.00 km on NH-127C. Additionally, three Special Repair (SR) works have been sanctioned in the financial year 2024-25, with a total length of 70.119 km and an approved amount of Rs.3.18 Crore.

A total of 4 (four) numbers of PBMC (Performance Based Maintenance Contract) works have been sanctioned during the financial year 2024-25, amounting to Rs 193.57 crore with a total length of 144.539 Km.

A total of 4 (Four) numbers of SOPD works have been sanctioned in financial year 2024-25, covering a total length of 40.29 Km, with a sanctioned amount of Rs.39.405 Crore.

Out of the total Budget provision of Rs. 294438.69 Lakhs made for the financial year 2025-26 Rs. 33662.41 Lakhs and Rs. 260776.28 Lakhs have been earmarked under the Revenue and capital head respectively. It seems that for the financial year 2025-2026 and amount of Rs. 624991.91 has been decreased then that of the previous year's revised Budget Estimates (2024-25)

Out of the total Budget provision of Rs. 320.88 Lakhs made for the financial year 2025-2026 Rs. 279.08 Lakhs and Rs. 41.80 Lakh have been earmarked under the Revenue and capital Head respectively. It seems that for the financial year 2025-2026 and amount of Rs. 4.1 Lakhs has been decreased than that of the previous year's revised Budget Estimates (2024-2025).The

CHAPTER-II**OBSERVATIONS AND RECOMMENDATIONS****P.W. (Bldg. & NH) DEPARTMENT.**

The Committee thoroughly discussed all the paras under the Grant no. 17 & 33 (Bldg. & NH) and observed the action taken on the recommendations of the DRSC Committee for the year 2025-2026. After threadbare discussion the Committee recommends as under:

GRANT NOS. 17 & 33

1. The Committee reiterates its earlier recommendation relating to Grant No. 17 of 25th Report, 2024-2025 to submit a status report within 3 months on the progress of State Convention Centre at Guwahati in the side of Guwahati Brahmaputra Ashoka and to complete the pending works as early as possible.
2. The Committee reiterates its earlier recommendation relating to Grant No 17 of 25th Report 2024-2025 for upgradation of Kolkata Assam House at Salt Lake including areas and other amenities.
3. The Committee reiterates its earlier recommendation No.14 of the 25th Report (2024-2025) for construction of a Mini Stadium for Lanka under Hojai District and to duly inform the Local MLA regarding allotment of requisite suitable land at the earliest.
4. The Committee reiterates its earlier recommendation No.16 of the 25th Report (2024-2025) to construct a Mini Stadium at Boko LAC.
5. The Committee reiterates its earlier recommendation No.20 of the 25th Report (2024-2025) for construction of a Mini Stadium at Ulubari area of Bijni and to duly inform the Local MLA regarding allocation of land for the said stadium at the earliest.
6. After threadbare discussion, the Committee directs the department to upgrade Circuit Houses all over Assam on priority basis.
7. The Committee reiterates its earlier recommendation No.22 of the 25th Report (2024-2025) for construction of a circuit house at Nazira.

8. The Committee recommends to ensure completion of construction of ITI building at Nidanpur, Lakhipur in Goalpara district under MSDP/PMJVK.
9. The Committee recommends for construction of Mini Stadium at Tangla in Udalguri district.
10. The Committee recommends for construction of District Stadium to be started at the places which were not included earlier.
11. The Committee recommends the department for construction of Circuit House at Tamulpur district.
12. The Committee recommends to speed up the up-gradation work of State Highway from Mangaldai to Bhutia Chang via Tangla-Kalaigaon.
13. The Committee recommends to speed up the up-gradation work of Highway from Baihata to Bangalipara via Mohoripara-Goreswar.
14. The Committee recommends that the recently announced Asom Mala District Road of 25 km should cover minimum 2 LACs of the same district.
15. The Committee observes that the Government has stipulated availability of atleast 25 Bigha land for LAC level Sports Ground/Stadium in each LAC. But in some LACs, above required lands are not available.
Hence, the Committee recommends that in such LACs which have less amount of land may be considered to construct of Stadium in smaller land with less sports discipline.
16. The Committee recommends to construct boundary wall in Bokajan Civil Hospital at Bokajan, Koilamati PHE (10-bedded), Khakrajan PHE (10-bedded), Borlengri PHE (10-bedded) at Chotolengri in the Karbi-Anglong district.

The Committee recommends that the Budget allocation provided under Grant No.17 and Grant No.33 for the financial year 2025-26 for PWD (Building & NH) be approved by the August House.

The Action Taken Report on the recommendations made in the report may be submitted to the Committee within 90 (ninety) days from the date of its presentation in the House.


