**MOTIONS- MOVED**

Hon'ble Minister **Shri Chandra Mohan Patowary** moved the following Motions :-

A) “That this House do take up for consideration the Fifty-third Report of the Committee of Privileges in the matter relating to the breach of privilege arising out of—

- (i) the manhandling of the Hon'ble Deputy Speaker within the precincts of the House and the obstruction caused to him while entering the House by Hon'ble Member **Shri Nurul Huda**; and
- (ii) the derogatory remarks made against the Hon'ble Deputy Speaker inside the Assam Legislative Assembly and the public criticism levelled against him outside the House by Hon'ble Member **Shri Sherman Ali Ahmed**;

the said matters having been referred to the Committee of Privileges by the Hon'ble Speaker under his directions made in the House on the 25<sup>th</sup> and 26<sup>th</sup> March, 2025, respectively.”

The Motion was adopted.

B) “That this House, having considered the Fifty-third Report of the Committee of Privileges, wherein the Committee, after examining the evidence and circumstances of the case, has observed that the actions of Hon'ble Member **Shri Nurul Huda** in manhandling the Hon'ble Deputy Speaker within the precincts of the House and in obstructing him from entering the House, and the actions of **Shri Sherman Ali Ahmed** in making derogatory remarks against the Hon'ble Deputy Speaker inside the House and in publicly criticizing him outside the House, constitute a breach of privilege of the House; and the Committee having recommended that both the Members be suspended from the service of the House for the remainder of the Session; this House agrees with and accepts the recommendations contained in the said Report and resolves that **Shri Nurul Huda** and **Shri Sherman Ali Ahmed** be suspended from the service of the House for the remainder of the present Winter Session.”

The Motion was adopted.
