# AN ACT

to amend the Cotton College State University Act, 2011.

#### Preamble

Whereas it is expedient to amend the Cotton College State University Act, 2011, hereinafter referred to as the principal Act, in the manner hereinafter appearing; AMOSOAST

It is hereby enacted in the Sixty-sixth Year of the Republic of India as follows:-

(1) This Act may be called the Cotton College State University (Amendment) Act, 2015. No. 254 Dispur, Wednesday, 9th Septem

(2) It shall have the like extent as the principal Act.

(3) It shall come into force at once.

Amendment of Section 6. HO2. A 9 In the principal Act, for Section 6 with the marginal note thereof, the following shall be substituted, namely:-

"Property to remain with the Cotton College.

From the date of commencement of this Act, the 6 existing property, land and building and all liquid assets of the Cotton College shall remain with it as a Constituent College of the University."
