ASSAM ACT NO. IV OF 2014

(Received the assent of the Governor on 12th August, 2014)

THE ASSAM APPROPRIATION (NO. 1) ACT, 2014

AN ACT

to authorise payment and appropriation of certain further sums from and out of the Consolidated Fund of the State of Assam for the services of the financial year, 2013-2014.

Be it enacted by the Assam Legislative Assembly in the Sixty-fifth Year of the Republic of India as follows:-

Short title	1. This Act may be called the Assam Appropriation (No.1) Act, 2014.
Withdrawal of Rs.462,98,27,000 from and out of the Consolidated Fund of the State of Assam for the financial year, 2013-2014	2. From and out of the Consolidated Fund of the State of Assam there were paid and applied sums not exceeding those specified in column (3) of the Schedule amounting in the aggregate to the sum of Four hundred sixty two crore Ninety eight lakh Twenty seven thousand rupees towards several defrayed charges which had come in course of payment during the financial year 2013-2014 in respect of the services specified in column (2) of the Schedule.
Appropriation	3. The sums withdrawn from and out of the Consolidated Fund of the State of Assam by this Act and appropriated for the services and purposes expressed in the Schedule in relation to the said year ending on the Thirty-first day of March, 2014 is hereby authorised by this Act.
