It is hereby enacted in the Sixty-first Year of the Republic of India as follows :-

Short title, extent and commencement

- 1. (1) This Act may be called the Assam Women (Reservation of Vacancies in Services and Posts) (Amendment) Act, 2010.
- (2) It shall have the like extent as the principal Act.(3) It shall come into force at once.
