(Received the assent of the Governor on 31st March, 1979) THE ASSAM PROFESSIONS, TRADES, CALLINGS AND EMPLOYMENTS TAXATION (AMENDMENT) ACT, 1979

An Act

further to amend the Assam Professions, Trades, Callings and Employments Taxation Act, 1947.

Preamble.

Whereas it is expedient further to amend Assam the Assam Professions, Trades, Callings and Employments Taxation Act, 1947, hereinafter referred to as the principal Act, in the manner hereinafter appearing;

It is hereby enacted in the Thirtieth Year of the Republic of India as follows:-

Short title, extent and commencement. 1. (1) This Act may be called the Assam Professions, Trades, Callings and Employments Taxation (Amendment) Act, 1979.

(2) It shall have the like extent as the principal Act.

(3) It shall come into force from the lst day of April, 1979.

Substitution 2. For the existing Schedule annexed to of the Schedule to the principal Act, the following shall be sub-Assam Act Stituted, namely:-
