further to amend the Assam Amusements and Betting Tax Act, 1939.

Preamble.

Whereas it is expedient further to amend the Assam Amusements and Betting Tax Act, 1939, hereinafter referred to as the principal Act, in the manner hereinafter appearing;

Assam Act VI of 1939.

It is hereby enacted in the Fifty-eighth Year of the Republic of India as follows:-

Short title, extent and commencement.

- 1.(1) This Act may be called the Assam Amusements and Betting Tax (Amendment) Act, 2007.
 - (2) It shall have the like extent as the principal Act.
 - (3) It shall come into force at once.

Amendment of section 3.

- 2. In the principal Act, in section 3, in sub-section (1), in clause (d), after existing sub-clauses (i) and (ii), the following new sub-clauses shall be inserted, namely,—
 - "(iii) rupees ten per ticket where the cinematograph exhibition hall provides dolby and digital sound system;
 - (iv) rupees eight per ticket where the cinematograph exhibition hall provides push back seat;
 - (v) rupees seventeen per ticket where the einematograph exhibition hall provides air conditioning system with back-up generator."
