Act

to provide for the authorisation of appropriation of moneys out of the Consolidated Fund of the State of Assam to meet the amounts spent on certain services during the financial year ended on the 31st day of March, 1964, in excess of the amounts authorised or granted for the said services

It is hereby enacted in the Nineteenth Year of the Republic of India as follows:—

Short title 1. This Act may be called the Assam Appropriation (No.IV) Act, 1968.



Issue of Rs. 16,85,99,012 from and out of the Consolidated Fund of the State of Assam for the financial year 1963-64.

2. From and out of the Consolidated Fund of the State of Assam, the sums specified in column (3) of the Schedule amounting in the aggregate to the sum of sixteen crores, eighty-five lakhs, ninety-nine thousands and twelve rupees shall be deemed to have been paid and applied to meet the amounts spent for defraying the charges in respect of the services specified in column (2) of the Schedule during the financial year ended on the 31st day of March 1964, in excess of the amounts authorised or granted for those Services for that year.

Appropriation.

3. The sums deemed to have been paid and applied from and out of the Consolidated Fund of the State of Assam under this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the financial year ended on the 31st day of March 1964.
