Subject: Payment of RG etc.

Will the Minister of Revenue & Disaster Management, Department be pleased to state:

- (a) Whether RG paid to NOK of Lt. Sajim Uddin, s/o Abdul Kaddus of Chaysimana vide Baghbar PS GDE no. 206 dated 15-07-2018?
- (b) Whether RG paid to Abdul Sattar, Sahajamal s/o Abdul Sattar, Saijuddin s/o Abdul Sattar, Rafiqul Islam s/o Lt. Moyan Uddin of Paschim Moinbari wrt my memo no. 45 / D - 2(i)(B) / 2022 - 23 dtd 10-03-2025 to DC, Barpeta?
- (C) Whether RG proposed vide no. KGC.2/09-10/2440 dated 02-02-2012 paid to Abul Kalam Azad?
- (d) Whether RG proposed vide no. BBRC/RR-04/2015/478 dtd 23/05/2018 paid to Shahjahan Ali?
- (e) Whether RG proposed vide no. BBRC/RR-04/2015/398-400 dtd 26-05-2020 paid to Fulchan Ali, Surat Ali, Soleman Ali, Sorbhan Nessa, Abdul Barek and Kamal Khan?
- (f) If yes, please furnish details in each case including CO's proposal.
- (g) Whether RG proposed by DC, Bajali vide no. BJRR-01/2022/Pt-I/171 dtd 19-03-2025 paid to Muslem Ali, Ahammad Ali and Sagar Ali of Kurobaha? Please furnish copy of DC's proposal.

**Answer**

The Hon'ble Minister, Revenue & D.M. Department Shri Keshab Mahanta will reply:

- a) RG to NOK of Lt.Sajim Uddin S/o Abdul Kaddus of Chaysimana village under Baghbar Rev. Circle is yet to be disbursed, as the body of the deceased person could not be recovered till date. Due to non-recovery of the body, the proposal against Lt.Sajim Uddin could not be submitted. However, as the person has not been heard for the last 7 years under the provision of Bharatiya Sakshya Adhiniyam, 2023, the NOK of the person may approach the civil court to declare the person as dead and thereafter may obtain the Death Certificate. In this regard, DC Barpeta has been directed to take needful action to communicate with the NOK of Lt.Sajim Uddin for obtaining the Death Certificate for further action.
- b) Ex-gratia grant amounting of Rs.12,00,000.00 (Rupees twelve lakh) only has already been paid to Abdul Sattar vide order dated 02/01/2025 in connection with death of his two sons and one daughter due to fire incident on 13-10-2011 under Kalgachia Rev Circle. Moreover, RG amounting to Rs. 3,80,400.00 (Three lakh eighty thousand and four hundred) only in favour of Abdul Sattar s/o Lt. Josim Uddin, Shaiz Uddin s/o Abdul Sattar, Shah Jamal s/o Abdul Sattar and Nasir Uddin s/o Lt. Rafiqul Islam has also been paid by Revenue & DM Department through DBT.
- c) RG in respect to Abul Kalam Azad could not be paid due to non-availability of the requisite supporting documents. In this regard, DC Barpeta has communicated with SSP, Barpeta and Senior Station Officer, Barpeta for requisite report for further action.
- d) RG in respect to Shahjahan Ali could not be paid due to non-availability of the requisite supporting documents. In this regard, DC Barpeta has directed the Circle Officer, Baghbar Revenue Circle to take steps for obtaining the requisite documents for further action.

- e) The Ex-gratia grant for an amount of Rs.4,00,000.00 (Rupees four lakh) only as per SDRF norms has been sanctioned and paid to NOK of Lt. Fulchan Ali. Regarding the claims related to the cattle loss of Abdul Barek and Kamal Khan, could not be established that the losses occurred due to the same lightening incident. The relevant veterinary report was also not found pertaining to the death of cattle/animals. Further, regarding ex-gratia claim due to injury by Surat Ali, Soleman Ali and Sorbhan Nessa, they were unable to submit any medical documents of injury during the lightning as per SDRF norms.
- f) As stated at (e) above.
- g) RG proposal in respect of Ahammad Ali, Muslim Ali and Sagar Ali for house damage has already been disbursed vide order no: ECF No.663346/57 dated 18/09/2025.
