- (a) No project of Sonai LAC has been implemented under Asom Mala. The selection of roads under the Asom Mala Projects is not carried out on the basis of Legislative Assembly Constituency. So far, work of Sonai LAC could not be included in the scheme in which the roads are selected as per priority, taking into consideration various parameters such as the existing condition of the road, traffic intensity, connectivity requirements, strategic importance, integration with other infrastructure, etc.
- (b) No any "NOC" was given by Public Works Road Department to construct Commercial Shops near Sonai PWD Inspection Bungalow to Sonai Municipality Board.
- (c) In this connection the concerned Executive Engineer of PWRD has already written letters to Circle officer, Sonai Revenue Circle as well as District Commissioner, Cachar District, Silchar regarding unauthorized Construction activities by Sonai Municipal Board. Sir,
With reference to the subject cited above, I would like to bring to your kind notice that the Sonai PWD Inspection Bungalow (IB), which falls under the jurisdiction of the PWRD, Sonai Territorial Road Sub-Division, has been utilized by the Sonai Municipal Board for its official activities over the past few years.

It has recently come to our attention that the Sonai Municipal Board has commenced the construction of commercial shops along the outer boundary wall of the Inspection Bungalow premises. Specifically, this construction is taking place over the RCC-covered drain along the SK Road side. This activity has been initiated without obtaining the necessary prior permission or formal approval from the competent authority of the Public Works (Roads) Department.

Such unauthorized construction is likely to adversely affect the drainage system in the area, poses a significant risk of encroachment on Government land, and may lead to serious legal and administrative complications.

This is for your kind information and necessary action.

Sir,

With reference to the subject cited above, I have the honour to bring to your kind notice that the Sonai PWD Inspection Bungalow (IB), under the jurisdiction of the PWRD, Sonai Territorial Road Sub-Division, has been under the temporary occupation of the Sonai Municipal Board for its official activities for the last few years.

It has recently been observed that the Sonai Municipal Board has unilaterally started constructing commercial shops along the outer boundary wall of the Inspection Bungalow. This construction is actively being carried out directly over the RCC-covered drain on the SK Road side. Crucially, this development has been initiated without securing the mandatory prior permission or official clearance from the competent authority of the Public Works (Roads) Department.

This unauthorized activity threatens to severely disrupt the local drainage system, leads to direct encroachment on Government property, and will inevitably invite legal and administrative complications.
