**Questions:**

Will the Minister of Food, Public Distribution & Consumer Affairs Department be pleased to state :

- (a) Will the Govt. furnish details regarding any Fair Price Shop Licence which is in a state of defunct caused due to Death/Surrendered/Cancellation in Kamrup Metro District within Guwahati City Habitation ?
- (b) If so, would you kindly provide the location of such F.P. Licence Shop with particulars in the floor of the Assembly ?
- (c) Whether the Department has any proposal for newly sanctioning of F.P. Shop Licence in the state as Ration Card holders are presently increasing in a large extent then earlier ?
- (d) Whether a fixed allowance will be considered for all the Fair Price Shop Licence holder to avoid disparity of present commission being received by them ?

**Answers:**

Hon'ble Minister of Food, Public Distribution and Consumer Affairs, Assam, Shri Kaushik Rai will answer :

- (a) Yes. The details of death / surrendered / cancellation / location of such F.P. shop and details of tagging of such F.P. shop of Kamrup (M) District has been enclosed at **Annexure- A** and uploaded on the Assam Legislative Assembly website [www.neva.gov.in](http://www.neva.gov.in) as per the directives of the Assam Legislative Assembly.
- (b) As stated in **Annexure -A** and uploaded on the Assam Legislative Assembly website [www.neva.gov.in](http://www.neva.gov.in) as per the directives of the Assam Legislative Assembly.
- (c) New Licence under Assam Public Distribution of Article Order, 1982 may be issued for functioning as Fair Price Shop Dealer only against a vacant position arising due to surrender / expiry / cancellation of functional Fair Price Shop having e-POS Device and existing in the smart PDS portal with more than 50 Nos. of Ration Cards. The executive order regarding issue of Retail Licence under APDAO, 1982 (As amended) has been enclosed as **Annexure- B** and uploaded on the Assam Legislative Assembly website [www.neva.gov.in](http://www.neva.gov.in) as per the directives of the Assam Legislative Assembly.
- (d) No proposal for providing fix allowance to the Fair Price Shop Dealers of Assam is under consideration. However at present Govt. has been providing @ Rs. 180/- per qtl. as Commission to the Fair Price Shop Dealers of Assam for distribution of PMGKAY rice. Moreover, FPS dealers got an amount as Commission for distribution of subsidized Masur Dal, Sugar and Salt @ Rs. 2.00/kg of each commodities during the period Nov'25 to May'26.

**EXECUTIVE ORDER**

**Subject: Procedure for issue of Retail license under Assam Public Distribution of Articles (APDA) Order, 1982 (as amended).**

1. New Retail license under Assam Public Distribution of Articles(APDA) Order, 1982 shall be issued for functioning as Fair Price Shop dealer only against surrender/ expiry/cancellation of Functional Fair Price Shop having-PoS Device and existing in the SMART-PDS portal with more than 50 No. of ration cards.
2. Against any vacancy arising out of conditions stated in point-1. applications shall be received for issuance of retail PDS license from bonafied permanent resident of the respective area in duly filled up Proforma A as available in Assam Public Distribution Articles(APDA) Order, 1982.
3. The applicant must be having minimum educational qualification of Class X Passed.
4. The applicant's age must be between 18 to 45 years.
5. The applicant should not be salaried employee under any Govt./Semi-Govt./Private Sector organization.
6. The applicant must possess minimum financial condition required to run the business of a Fair Price Shop.
7. The applicant must own/hire suitable storage facility for safe keeping of notified articles.
8. The proposed Fair Price Shop premises must be located in a land having KP patta.
9. The applicant must submit his/her self-declared annual income certificate.
10. The duly filled up application form should be submitted along with necessary documents (viz. Age Proof, Address Proof, Aadhaar number, PAN, Voter card, Income Certificate, bank details, documents for educational certificate). The application form should be submitted in the O/o, the District Commissioner/Sub-Divisional Officer/Co-District Commissioner/Licensing Authority.
11. The application may also be submitted through Sewa Setu/SMART PDS Platform.
12. After submission of application form to the Licensing Authority, the Licensing Authority shall endorse it to the Branch Officer of Food, Public Distribution & Consumer Affairs(FPD&CA) for detail enquiry report. The Branch Officer will conduct the enquiry through the concerned Area Officer of FPD&CA. The Area Officer will examine the following points for submission his/her enquiry report:
  - (a) The nos. of Ration Card (AAY/PHH) to be covered with detailed list.
  - (b) The financial status of the Applicant.
  - (c) Location of the proposed Fair Price Shop premises.
  - (d) Storage condition.

- (e) Applicant's educational qualification.
- (f) Applicant's age.
- (g) Applicant's professional status.
- (h) Land holding status.

13. After due enquiry by the concerned Area Officer, FPD&CA, report shall be submitted to the concerned Branch Officer of FPD&CA/District Commissioner/Sub-Divisional Officer/Co District Commissioner/ Licensing Authority.
14. On receipt of satisfactory report from the Area Officer regarding fulfillment of the above mentioned conditions by the applicant, the application shall be processed for issuance of license to the applicant otherwise of which the application will be summarily rejected and the applicant will be informed accordingly.
15. Prior to issue of the Retail license, the applicant shall be informed about submitting the license fee in the form of treasury challan or through online platforms. The license fee is to be paid within 15 (fifteen) days from the date of receipt of the information regarding the acceptance of his/her application.
16. (a) In case of more than 1 (one) applicant against a vacancy for issuance of PDS Retail license, priority should be given in the following order subject to fulfillment of all the eligibility conditions mentioned above :
  - (i) Person with Disability (PwD)
  - (ii) Widow
  - (iii) Women
  - (iv) Self Help Group (SHG)
  - (v) Economically weaker among the applicants.

(b) In case of license issued under Clause 16 (A), the licensing Authority shall issue the license with a Speaking Order.

17. In case of issuance of PDS Retail license against death of an existing Fair Price Shop dealer, preference shall be given to the Next of Kin of the deceased dealer. A NOC (No Objection Certificate) shall be obtained from the deceased Fair Price Shop Dealer's family if the license is issued to any other applicant.
18. The entire process of issuance of new license against surrender/ expiry/cancellation of existing Fair Price Shop, following due procedure must be initiated and completed in the SMART PDS portal in the relevant module to ensure digitization of the new licensee details in the database simultaneously.

The Order will come into force with immediate effect.
