No.UDD(M)263/2017/13- In pursuance of Section 4 of the Assam Municipal (Amendment) Act, 2017, the Governor of Assam is pleased to convert and rename existing Town Committees / Municipal Boards of Assam into appropriate category of Municipalities divided into 5 (five) categories on the basis of population therein as per the latest Census figures as described below.

This refers to the Urban Development Department's letter no. MA. 582/97-143 dated 21.12.1999 that had put a ban on fresh appointment in Municipal Boards and Town Committees.

It has been observed that some Municipal Boards and Town Committees are moving Govt. for obtaining approval for making fresh recruitment / engagement of personnel in Municipal Boards / Town Committees. It is hereby clarified that the process for having a uniform staffing pattern in the Municipal Boards and Town Committees of Assam is under active consideration of Govt of Assam and as such the Govt. is not in a position to entertain such proposal.

The Director of Municipal Administration, Assam vide letter no. DMA (P)90/2010/187 dated 9th August, 2016 has also requested all the MBs and TCs not to appoint / engage personnel till the disposal of the matter on the staffing pattern by Govt.

The Chairmen / Chairpersons / Executive Officers of the MBs and TCs of Assam are instructed not to make fresh recruitment in their MBs & TCs and not to move the Govt with such proposal till the proposed uniform staffing pattern for the MBs and TCs is finalized by the Govt.

This is issued with the approval of Hon'ble Minister, Urban Development Department, Assam.
