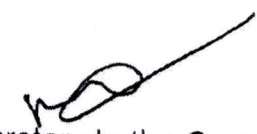
The Chairperson requested the members to put forward their views about the quality of applications.

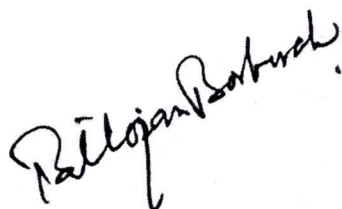
