Barpeta District.**

Will the Minister of Home and Political Department be pleased to state :

- (a) Please furnish the total number of cases referred to the Foreigners Tribunals in Barpeta District up to 30th June, 2026.
- (b) Please furnish the Tribunal-wise number of cases disposed of by the Foreigners Tribunals in Barpeta District up to 30th June, 2026.
- (c) Please furnish the Tribunal-wise number of persons declared as foreigners by the Foreigners Tribunals in Barpeta District up to 30th June, 2026.
- (d) Please furnish the number of declared foreigners who have been deported, detained in Transit/Detention Centres, and those who are absconding, as on 30th June, 2026.
- (e) Please furnish the Tribunal-wise number of pending cases before the Foreigners Tribunals in Barpeta District as on 30th June, 2026.
- (f) Please furnish the names of the Members presently serving in the Foreigners Tribunals in Barpeta District, along with their date of posting and the Tribunal to which they are attached.

ANSWER

Hon'ble Minister of Home and Political Department Dr. Himanta Biswa Sarma will reply :

- (a) A total of 40744 cases have been referred to the Foreigners' Tribunals of Barpeta District since inception till 31st May 2026.
- (b) The Tribunal-wise number of cases disposed of by the Foreigners' Tribunals in respect of Barpeta District is enclosed as **Annexure-"A"**.
- (c) The Tribunal-wise number of persons declared as foreigners by the Foreigners' Tribunals in respect of Barpeta District is enclosed as **Annexure-"B"**.
- (d) During the said period, 04 (four) nos. of Convicted Foreign Nationals (CFNs) were deported from Barpeta District.

At present, 12 (twelve) nos. of Declared Foreign Nationals (DFNs) of Barpeta District are lodged in Holding Centre , Matia, Goalpara.

As on date, out of 7837 Declared Foreign Nationals of Barpeta District , 4793 Declared Foreign Nationals (DFNs) are absconding while 3044 are either on bail, have expired, subsequently declared as Not Foreigner by Higher Courts, not to be apprehended by Court Orders etc.

- (e) The Tribunal-wise number of pending cases before the Foreigners' Tribunals in respect of Barpeta District is enclosed as **Annexure-"C"**.
- (f) The names of the Members presently serving in the Foreigners' Tribunals in Barpeta District along with their date of posting is enclosed as **Annexure-"D"**.
