- (a) What amounts of fund were allotted for works in the complex of Ataur Rahman College of Education, Udmari under MLALAD w.e.f 2006 to 2011 and 2016 to 2019 and under MPLAD w.e.f 2019 to 2024 ? Please furnish details.
- (b) What is the present status of the aforesaid schemes?
- (c) What amounts of fund were allotted under MPLAD for Barpeta HPC during 2014 to 2019 and 2019 to 2024? Please furnish Details.
- (d) What amount of funds were utilized and what could not be utilized during their respective tenure?
- (e) What amount of fund was allotted for construction of boundary wall of Mandia HSS under MPLAD w.e.f 2009 to 2014 ?
- (f) What amount was utilized? Please furnish details of physical achievement.
- (g) Is the boat with MPLAD of ex-MP Sirajuddin Ajmal for Bamundongra Ghat missing now? If not, where the boat is operating now? Please furnish amount spent and year of sanction.

REPLY:

Sri Rameswar Teli, Hon'ble Minister of Transformation & Development Department replies as follows :

Answer(a) : The following amounts of fund were allotted for works in the complex of Ataur Rahman College of Education, Udmari under MPLADS w.e.f 2019 to 2024 :

Further, it is to be mentioned that no fund was allotted for works in the complex Ataur Rahman College of Education, Udmari under MLAADS Fund w.e.f 2006 to 2011 and 2016 to 2019.

Answer(b) : The present status of the aforesaid scheme is completed.

If not, where is the boat operating now?

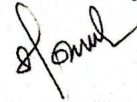
