Subject: Payment of RG etc.

MLA: Shri. Sherman Ali Ahmed.

Will the Minister of Revenue & Disaster Management, Department be pleased to state:

- (a) As per reply of unstarred QN-12 dated 28-12-2020, Rs. 5, 10 and 1 crore were budgeted during 2015-16, 2018-19 and 2019-20 respectively and Rs. 200 crore was allocated during 2020-21 for rehabilitation of erosion affected families but the same couldn't be utilized due to non-receipt of proposal from the DCs. What action is taken for such inaction of DCs? When the families shall be rehabilitated?
- (b) Is it true that RG has to be paid in case of disaster (flood) within 24 hours of death? Please furnish a copy of notification/order to that effect.
- (c) Why RG to Najum Uddin of village Chunpura who died of lightening stroke on 15th March, 2026 is not paid till date? Please furnish a copy of CO, Baghbar's proposal.
- (d) Please also furnish a copy of proposal vide no. KGC.32/13/140 dtd 12-12-2013.
- (e) How many revenue villages of Baghbar & Kalgachia Revenue Circle don't have trace maps? Please furnish list.

Answer

The Hon'ble Minister, Revenue & D.M. Department Shri Keshab Mahanta will reply:

(a) Govt. of Assam had introduced two Rehabilitation Policies for People affected by Erosion in Assam viz. Chief Minister's Special Scheme for Rehabilitation of Erosion Affected Families in Assam, 2015 and Rehabilitation Policy for Erosion Affected Families of Assam, 2020.

However, the Govt. of Assam vide Notification No. ECF 236845/32, dtd.18.11.2023, rescinded both the then existing policies (copy enclosed at **Annexure – 'A'**) as they were not in consonance with the SDRF/NDRF Guidelines.

At present, people affected by erosion in Assam are provided with RG for House Damage as per SDRF/NDRF Norms subject to their fulfilment of eligibility as per Assam Land Policy 2019.

The 15th FC had recommended and allocated ₹1000 Cr for the assistance of the displaced people by erosion to address the issue of displacement across India. Against this allocation, ASDMA (Assam State Disaster Management Authority) has submitted a Detailed Project Report (DPR) for Rehabilitation for People affected by Erosion in Assam amounting to ₹61.34 Cr to Govt. of India, which is yet to be approved.

(b) There is no such Notification/Order stating that RG has to be paid in case of disaster (flood) within 24 hours of death.

However, all efforts are made by the District Administration to hand over the Ex-Gratia amount to the NoK of the deceased after completion of basic essential formalities. Further, in FY 2026-27, a total amount of **₹7.00 Cr @ ₹20 lakhs** for each district has already been released as advance RG Ex-Gratia fund by this Department.

(c) Ex-Gratia in respect of NoK of Lt. Najum Uddin has been sanctioned by O/o DC, Barpeta for an amount of ₹400000.00 (Rupees four lakh) only to the NOK vide Office Order No. BDM-18/2026/lighting/65, dtd-18/07/2026. Payment has already been disbursed to the NoK of the deceased by DC, Barpeta.

(d) Copy enclosed at **Annexure – 'C'**.

(e) As informed by O/o DC, Barpeta, a total of 74 villages under Baghbar Rev. Circle do not have village Maps or Maps are in dilapidated conditions (list enclosed at **Annexure – 'D'**) and a total of 70 villages under Kalgachia Rev. Circle do not have Vandyke Maps (list enclosed at **Annexure – 'E'**)

It is also decided to frame a new Rehabilitation Policy for erosion affected families after approaching the Government of India for issuance of necessary guidelines.

This notification shall come into force immediately.

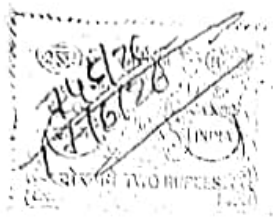

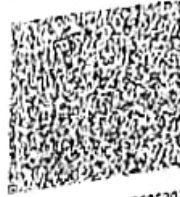
