Subject: Healthcare Infrastructure.

Md. Mohibur Rohman, Hon'ble MLA

Will the Minister of Health & Family Welfare Department be pleased to state:

- (a) Will the Govt. furnish the sanctioned strength, filled-up posts, and vacancies of doctors, nurses, and other healthcare personnel in the Government health institutions of South Salmara-Mankachar District.
- (b) How many departments are currently operational at the District Civil Hospital, South Salmara-Mankachar, and the number of specialist doctors deployed in each department.
- (c) Whether the Government has any proposal to establish CT scan, ICU, Blood Bank, Post-Mortem, and Morgue facilities in Mankachar Assembly Constituency; if so, the present status and likely timeline for implementation.
- (d) The details of healthcare infrastructure projects sanctioned, ongoing, and completed in South Salmara-Mankachar district during the last three years, along with their present status.

Answer

Hon'ble Minister, Health & Family Welfare Shri Ashok Singhal will reply:

- (a) The details of sanctioned strength, filled up posts and vacancies of doctors, nurses and other healthcare personnel in the Government health institutions of South Salmara Mankachar district is enclosed in **Annexure-A**.
- (b) There are 10 (Ten) departments are available at the District Civil Hospital, South Salmara Mankachar District.

- (c) Under the Free Diagnostic Services Initiative, free laboratory and X-ray services are presently being provided at health facilities in South Salmara District. In addition, the site for installation of CT Scan services has been identified at Hatsingimari Civil Hospital and the CT Scan service is planned to be implemented within the financial year 2026-27. The biomedical equipment required for ICU services is available and ready for operationalization. The required biomedical equipment for Blood Bank services is available, and the necessary infrastructure is in place. As reported by Joint DHS, South Salmara Mankachar the execution of construction of Morgue along with Post-Mortem room at District Hospital Hatsingimari is done by PWD (Building), Goalpara & South Salmara District Territorial Building Division and the same is under process for handing over.

Sl. No.	Name of Establishment	Present status
1.	CT Scan	CT Scan service to be made functional in FY 2026-27.
2.	ICU	Medical equipment is available and the required Staffs are also available. However, Oxygen supply is currently unavailable due to damage of connecting pipe line to PSA plant. As per NHM (HQ) the tender process for repair/replacement will take 6 (six) months. After that the ICU can be made functional.
3.	Blood Bank	The required medical equipment has been partially delivered, and the necessary Infrastructure is in place. The process of applying for the licence to commence Blood Bank services has now been initiated.
4.	Post Mortem and Morgue	The construction of the Mortuary building has been completed and is likely to be delivered shortly by PWD (Building).

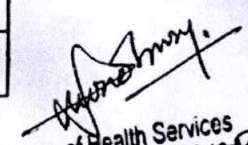

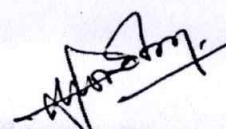

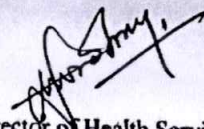
