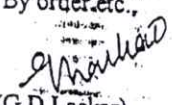

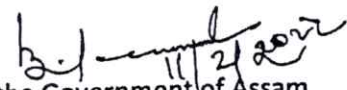

Respected Sir/Madam,

As you are aware the preparations for the Census 2027 have started. To ensure the complete coverage in Census, the villages and towns are divided into Enumeration Blocks of nearly uniform size and each such block is allotted to an enumerator for collection of census data so that there is no omission or duplication. Therefore, it is essential that the boundaries of administrative units are not disturbed after the demarcation of the Enumeration Blocks till the completion of the Census Operations.

2. I would request you to direct the concerned departments to ensure that the proposals for making any change in the boundaries of existing municipalities, revenue villages, tehsils, sub- divisions, districts etc. including those which may be taken up in near future are finalized and given effect before 31st December, 2025. The jurisdictional changes are to be intimated to the concerned Census Directorates in the State/ UT and the Office of the Registrar General, India as and when such changes occur. The boundaries of administrative units for Census 2027 will be frozen as on 31st December, 2025.

3. Appointment of census functionaries including enumerators/supervisors and allocation of work among them shall be taken up soon in close liaison with the State/District administrations before going for the Houselisting and Housing Census (1st phase) commencing from 1st April 2026. It would be followed by the Population Enumeration in February 2027.

4. I shall be grateful, if you could kindly issue necessary instructions to all concerned in your State/UT to ensure that no changes, whatsoever, are effected in the boundaries of administrative units during the period from 1st January, 2026 to 31st March, 2027 and all the jurisdictional changes made on or before 31 December 2025 are informed to us.
