Subject: Payment of RG etc.

MLA: Shri. Sherman Ali Ahmed.

Will the Minister of Revenue & Disaster Management, Department be pleased to state:

- (a) Is it true that Helmina Khatun and Jannat Parbin, d/o Hussein Ali of Village Kapoha died of drowning on 18-03-2026?
- (b) If yes, why RG is not paid yet? Please furnish a copy of CO's proposal.
- (c) Consequent upon CO, Kalgachia's proposal vide no. KGC/DM-4/Fire/2017-18/1542 dated 08-10-2024, why RG has not yet been paid to Babul Haque of village Kismat Moinbari? Please furnish a copy of CO's proposal.
- (d) Is it true that the household properties of Bisha Miah, s/o Lt. Ahammad Ali of village Satrakanara were burnt on 28-06-2026?
- (e) Is it also true that household properties of Abdus Samad, s/o Lt. Askor Ali of village Hapachar were burnt on 27-06-2026?
- (f) If yes, why RG is not paid to Bisha Miah and Abdus Samad?
- (g) Is it true that Afaj Ali, s/o Lt. Ismail Hussain of village Bonghugi died of drowning on 23-06-2026?
- (h) If yes, why RG is not paid yet?

Answer

The Hon'ble Minister, Revenue & D.M. Department Shri Keshab Mahanta will reply:

- (a) Yes, as per the report of the Circle Officer, Baghbar Revenue Circle, Helmina Khatun and Jannat Parbin, daughters of Hussein Ali of village Kapoha, died due to drowning in a **private pond** on 18-03-2026.
- (b) As per the enquiry conducted by the Circle Officer, both the girls accidentally fell into a private pond and died. The incident was not related to floods or any notified natural calamity. Further, as per Govt. Notification No. RR.33/2014/66, dated 15-11-2014, (copy enclosed at **Annexure – 'A'**) there is provision for payment of Ex-gratia amounting to ₹2.00 Lakhs to the NOK of person killed due to accident in public places or in public carriers. Since the incident occurred in a private pond and not in any public place, the deceased are not eligible for ex-gratia as per existing norms. Copy of CO's proposal enclosed at **Annexure – 'B'**.
- (c) The amount of ₹1,20,000/- (Rupees One Lakh Twenty Thousand) only as RG – House Damage (Fire) has been paid in favour of Shri Babul Hoque of village Kismat Moinbari via DBT vide Order dtd.18.07.2026. Copy of CO's proposal enclosed at **Annexure – 'C'**.
- (d) Yes, as reported by O/o DC, Barpeta.
- (e) Yes, as reported by O/o DC, Barpeta.
- (f) The fire incident in respect of Bisha Miah occurred on 28.06.2026. CO, Baghbar, has submitted the proposal to O/o DC, Barpeta vide Letter No. BBRC-/06/2022/NC/770, dated 14-07-2026.
The fire incident in respect of Abdus Samad occurred on 27.06.2026 and the requisite documents are being collected by CO, Baghbar, for submission of formal proposal. On receipt of formal proposals from O/o DC, Barpeta, RG will be disbursed to affected persons through DBT as per norms.
- (g) Yes, as per the report of the Circle Officer, Kalgachia Revenue Circle, Afaz Uddin (and not Afaz Ali), son of Late Ismail Husain of village Bonguhui, died due to drowning on 23-06-2026.
- (h) As reported by the Circle Officer, Kalgachia Revenue Circle, Afaz Uddin (not Afaz Ali) aged about 55 years, S/o- Late Ismail Hussain, died due to accidental drowning in a **private pond** while going to feed fish. The incident is not related to flood or any other notified Natural calamities. Therefore, the case is not eligible for Ex-gratia in accordance of Govt. Notification No. RR.33/2014/66 dated. 15-11-2014.

The Governor of Assam is pleased to revise the quantum of relief in respect of persons, who were killed / injured due to extremist violence / terrorist violence / acts of miscreant / communal violence / ethnic violence / group clash / firing of security forces / accident etc., who were kidnapped / abducted by extremist/ terrorist / miscreants and whose dwelling houses are fully burnt / damaged whether due to acts of extremist / terrorist / miscreants or during communal violence / ethnic violence / group clash.

This notification shall come into force with immediate effect.

The revised rates shall be applicable in respect of the incidents, which may occur in the State as on or after the date of issue of the notification in super session of the previous notifications in this regard. The incidents prior to 15th November, 2014 will be governed by the O.M. / notifications relevant to the period concerned.

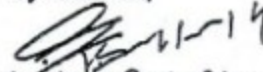

With reference to the subject cited above, I have the honour to forward herewith the concerned LRA report along with the application (in original) with its enclosures submitted by Hussein Ali, S/o- Raham Ali Ahmed of village Kapoha of Jania mouza under Baghbar Revenue Circle regarding seeking for financial assistance in connection with drowning and death incident of his 2 (two) daughters for favour of your kind information and necessary action. In this regard it may be mentioned here that as per report of concerned LRA, it is found that both the girls were accidentally fell down in a **private Pond** and died. The pond was **not inundated** by flood water at that time, hence it is found that the death incident is **not relating to Flood**. And as per the report of concerned LRA it is found that the place of incident is a 'Private place'.

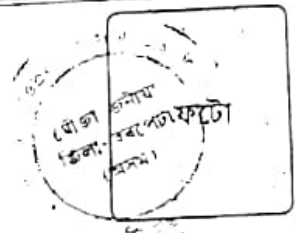

Accordingly, local enquiry had been done. During the enquiry it is revealed that both the deceased are sister. It has found that the cause of death was drowning. The incident was reported to executive magistrate and inquest has been done through Honorable Circle officer of Baghbar Revenue. Thereafter, Post-mortem examination had been done at FAAMCH, Barpeta.

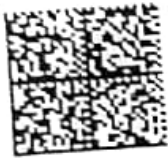

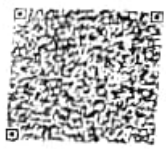

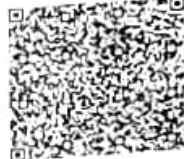

Sir,

With reference to the subject cited above, I would like to inform you that on 18/03/2026 at about 03:00 PM, the Medical Officer of Mandia Model Hospital informed at Mandia Police Outpost in writing that one Helmina Khatun, aged about 12 years and Jannat Parbin, aged about 10 years, daughter of Hussain Ali, resident of village Kapoha, P.S. and District-Barpeta (Assam) had been brought dead to the hospital. Accordingly, the matter was entered in Mandia OP GDE vide Mandia O.P. GDE No. 353 dated 18/03/2026, and necessary investigation was done. During investigation, Police visited Mandia Model Hospital and found the dead body of HelminaKhatun and Jannat Parbin. From field enquiry it revealed that both HelminaKhatun and Jannat Parbin went for washing a dining table nearby a pond adjacent to their house. While washing table, they accidentally drowned into pond water and subsequently died.

During spot verification, no foul play or any suspicious circumstances came into light in connection with the deaths of HelminaKhatun and Jannat Parbin. Their death was occurred due to accidental drowning in the pond near by heir house.

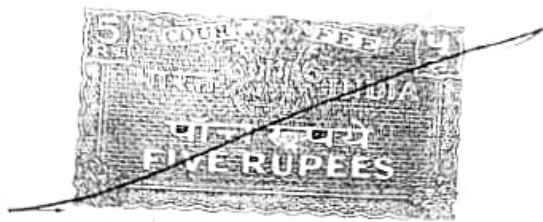

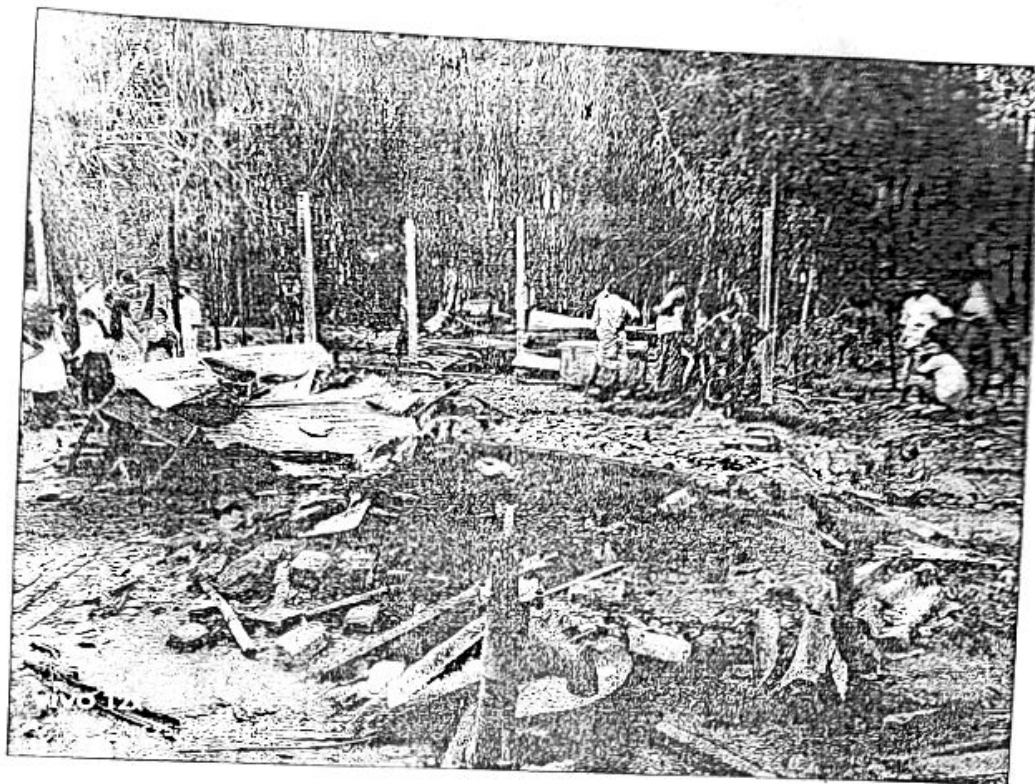
