Sub : Unfulfilled positions in various departments Md. Mohibur Rohman, Hon'ble MLA

Will the Minister of Personnel Department be pleased to state:

- (a) Will the Govt. furnish the list of vacant positions in various Government Departments in South Salmara Mankachar district?
- (b) Will the Govt. state the plan to fill up the vacant positions specially in the District Commissioner's Office, Hospitals, Colleges, Water Resource, Agriculture, Irrigation, Veterinary, Fishery etc?
- (c) Is the Govt. aware that the post of CEO of Zilla Parishad is vacant for more than 10 months? If so, what is the plan to fill up that post?
- (d) How many positions of department/establishment heads (including heads of colleges & hospitals) are filled up currently by Incharges? What is the plan to fill them up with permanent positions?

Answer

Dr. Himanta Biswa Sarma, Hon'ble Minister, Personnel Department will reply:

- (a) The list of vacant positions in various Government Departments in South Salmara Mankachar district is placed at “**Annexure-A**”.
- (b) A Task Force has been constituted vide Notification No. ABP-790175/4 dated 19/05/2026 under the Chairmanship of the Chief Secretary, Assam, for creation of 2 Lakh Government Jobs in Assam and for formulation, monitoring and implementation of a comprehensive roadmap for achieving the said objective. These job opportunities shall spread across the broader public sector ecosystem of the State, including Government Departments, Universities, Medical Colleges, Statutory Bodies, Societies, Sixth Schedule Councils, and companies with substantial State Government shareholdings.
- (c) The Govt. is aware of the vacancy of the post of the CEO of Zilla Parishad, South Salmara Mankachar district. The Personnel Department has initiated the process for posting suitable officer as Chief Executive Officer, Zilla Parishad, South Salmara Mankachar. Currently, Shri Kumar Gaurab Das, ACS (DR-2017), Additional District Commissioner, South Salmara Mankachar has been entrusted as in-charge Chief Executive Officer, Zilla Parishad, South Salmara Mankachar. The Copy of the order is placed at “**Annexure-B**”.
- (d) The details of the positions of the department/establishment heads (including heads of colleges & hospitals) which are filled up currently by Incharges are placed at “**Annexure-C**”. The Govt. is planning to fill up the positions as per the response mentioned at (b) above.
