NOTIFICATION

LLE 27/98/Pt/10583 In exercise of the Powers conferred by section 7 of the Assam Legislative Assembly Members' Salaries, Allowances and Pension Act 1958, as amended up to date, the Governor of Assam, in consultation with the Hon'ble Speaker, Assam Legislative Assembly is hereby to make the rules further to amend the Assam Legislative Assembly Members' Salaries, Allowances and Pension Rule as amended upto date hereinafter referred to as the principal Rules namely :-

Short title

1. (i) These rules may be called "The Assam Legislative Assembly Members' Salaries, Allowances and Pension (Amendment) Rule, 2005"

(ii) It shall come into force with effect from the 1st September, 2005.

Application

2. These rules shall be applicable to all the Members of the Assam Legislative Assembly including the Ex-Members.

Amendment of Rule 3
 Salary

3. In the principal Rules, in rule 3 the figure "Rs. 2000.00" shall be substituted by figure "Rs. 3000.00".

Amendment of rule 7
 constituency
 Allowance

4. In the principal Rules, in rule 7 the figure "Rs. 2500.00" shall be substituted by figure "Rs. 3500.00".

Amendment of rule
 7A contingency
 Allowance

5. In the principal Rules, in rule 7A the figure "Rs. 2000.00" shall be substituted by figure "Rs. 3000.00".

Amendment of rule
 7B Secretarial
 Allowance

6. In the principal Rules, in rule 7B the figure "Rs. 1500.00" shall be substituted by figure "Rs. 3000.00".

Amendment of rule
 7 C Other Facilities
 conveyance allowance

7. A Member of the Assam Legislative Assembly shall draw an amount of Rs. 6300/- per mensem alongwith his/her salary as conveyance allowances

7D (i) and (ii)
Telephone charge

8. In the principal Rules, in rule 7D (i) the figure " Rs. 1800.00" shall be substituted by figure " Rs. 2500.00 ". (for Members' Hostel Residence) and in rule 7 D (ii) the figure "Rs. 1200.00 " shall be substituted by the figure "Rs. 2000.00" (for Home Constituency)

Sitting Allowance

9. In the principal Rules, in rule 7D (iii) the figure " Rs. 200.00" shall be substituted by figure " Rs. 300.00 ".

Amendment of rule 25A
Travel Facilities

10. In the principal Rules, in rule 25A (I) Free Transit Facilities by Railway or A.S.T.C. shall be substituted as follows:-

Every Member shall be provided with money value coupon books for two non-transferable A/C II Tier passes which is entitled to him /her and his / her spouse or other person accompanying him/her to look after and assist him /her to travel at any time by railway in India, a distance not exceeding twenty thousand K.M. either or both the passes, during the financial year.

Provided that the journey is performed by the member and his/her spouse or any other person accompanying him /her to look after and to assist him /her by Air conditioned coach or by Air that the difference between the cost of such travel and the A/C II tier railway fare " including Rajdhani & Satabdi Train shall be adjusted against an amount of Rs. 29,742/- payable to the member in respect of his/her total entitlement of twenty thousand K.M. of travel by rail.

Mileage Allowance

11. In the principal Rules, in rule 29A the figure " Rs. 3.00" shall be substituted by figure " Rs. 4.00 ".

Amendment of rule 23
pension to Ex-MLAs

12. In the principal Rules, for the existing rule 23, the following shall be substituted :

"There shall be paid a Pension of Rupees 4000.00 (four thousand) per mensem to every ex-member who has served for a period of five years or for any period shorter than five years as a member of Assam Legislative Assembly after the commencement of the constitution of India.

Provided further that where any ex-member has served as aforesaid for a period exceeding five years, there shall be paid to him/her an additional pension of Rupees 200/- (two hundred) per mensem for every completed year, in excess of five years or so, however that, in no case the pension payable to such ex-member shall exceed subject to maximum of Rs. 7000/- per month.

Medical Allowances to
Ex-MLAs

13. Medical allowances at the rate of Rupees 1000/- (one thousand) per month.

Amendment of Rule 24
(A) (i) Family Pension

14. In the principal Rules, for the existing rule 24A the following shall be substituted :-

"Family Pension to the widow/widower shall be fixed at 50% of the amount of pension that the Ex-Member is entitled to draw at the time of his/her death. Also the holder of family Pension shall be entitled to draw medical allowances at the rate of Rupees one thousand per month along with the family pension ;

Provided that the quantum of family pension and the medical allowances shall be reviewed along with the review of pension and medical allowances of the Ex-Members by the Members Amenities and Facilities Committee of the Assam Legislative Assembly from time to time whenever constituted.
